

## SGBV Field Sub-Working Group – Za'atari Thursday, November 13, 2014 – UNHCR Meeting Room 2 – Meeting Minutes

## Chair: IRC

- Safety Audit Updates Safety audit data collection almost finalized. 250 individual interviews have been conducted using ICT4P and eight FGDs carried out with single households, regular households and the youth. All focus group discussions were disaggregated by gender. Focus group discussions targeting elderly and disabled are still pending. Age and disability task force is expected to carry them out and submit findings report by December 1<sup>st</sup>. safety audit task force members are also expected to submit a first draft of the report by December 1<sup>st</sup>. Upon completion the safety audit report will be reviewed by PRT, CP and SGBV members prior to endorsement and official presentations roll-out.
- 16 Days of Activism & Amani Campaign event Schedule has been finalized and official posters and information material under draft at the national level. Upon completion all materials will be distributed. An inter-agency AMANI campaign event is also expected to take place on Monday. December 1<sup>st</sup> in IRD tent district 6. The event is expected to last for 1.5 hrs and will include theatre plays, songs, drawings and art programs. - **RAIS GBVIMS Zaatari report** –Ana Belen Anguita presented September report on GBV-IMS data analysis. Together with the October analysis and the safety audit findings these will form the baseline for the GBV Za'atari sub-working group 2015 strategy, plan of action and TOR revision. Preliminary findings though highlight the need to booster GBV mainstreaming across different sectors and particularly with Education and Youth. **Action Point** = Chair to contact education and youth sector leads and invite them to the next SGBV meeting. Aim start discussions aimed at bolstering collaboration and integration of GBV sensitive approaches.
- District based orientation following the positive results of previous district based SOPs orientations and the continuous need to ensure refugees and district-based services providers are aware of referral mechanisms for GBV and CP, the members are looking at a second district based SOPs roll-out phase. Action Point = Include the district based SOPs orientations in the next SGBV/CP joint meeting to start planning and discuss next steps.
- SGBV/CP joint agenda members discussed agenda items to be included in the next SGBV/CP meeting. This will include a) district based orientations planning, b) remarks on the Convention on the Rights of the Child, November 28<sup>th</sup> and c) participation of education and youth leads for PRT related concerns in the camp. Action point = members to contact SGBV Za'atari SWG Coordinator, Elena Del Fabbro, <u>elena.delfabbro@rescue.org</u>, and Za'atari Child Protection SWG Coordinator, Tahir AliShah, <u>Tahir.AliShah@savethechildren.org</u> for any points to be included in the agenda. Chairs to contact education and youth sector leads for official invitation.
- Overview of Save The Children International (SCI) 2015 Child Protection Program in Zaatari presentation by Naima Chohan – focus on reducing violence against children, bolster engagement of Syrian children in child protection initiatives, facilitate a venue for dialogues on child related issues and promote access to safe spaces and other informal education opportunities such as literacy for children out of school and engaged in child labor. In doing so SCI will open child friendly spaces and two additional drop-in centers. To maximize inter-agency efforts SCI looks forward to further collaborated with other agencies.
