Brief update from ISWG	<p>Sector chair shared updates from the ISWG meeting, main points are:</p> <ul style="list-style-type: none"> Newly created livelihoods working group (LWG) had a meeting on 29 March. A draft ToR for the group is under review. A discussion on linkage of livelihoods working groups with other sectors to take place in LWG meetings. Anna Gaunt is the interim sector chair for the LWG (GAUNTA@unhcr.org) GenCap advisor will continue his role in supporting sector gender focal points network. GenCap advisor to provide support in gender analysis on sectors level and to support improving gender sensitivity. Gender focal point action plan needs to be on BNWG agenda and workplan. Services advisor taxonomy is finalised and the system will be launched in April. Sector-level and localized training sessions will take place in May. The Prevention of Sexual Abuse and Exploitation (PASE) focal points network developed an inter-agency community based complaint mechanism. A draft protocol is prepared in consultations with refugees and partners.
OCHA Brief on Humanitarian Fund (HPF)	<ul style="list-style-type: none"> OCHA had their first advisory board meeting to discuss the Jordan Humanitarian Fund (JHF), previously called Emergency Response Fund (ERF) and the upcoming call for proposal.

	<ul style="list-style-type: none"> A programmatic priority document, prepared by ISWG in consultation with sector chairs, presented suggested priorities to the JHF call for proposal. The projects should focus on four sectors; shelter, health, protection and basic needs. The thematic objective of JHF are; 1.) Meeting critical needs in areas where NGOs have comparative advantages 2.) Critical gap filling (firefighting) 3.) Emergency Response-sudden change in context 4.) Impact. OHCA will consider projects from other sectors if they demonstrated the JHF funds priorities. JHF call for proposal ceiling amount to 5 million USD with two windows: one for Jordan and a second for southern Syria (cross-border). The call to be launched during the second week of April and it will be open for two weeks with possible extension. The call is open only for NGOs who successfully submitted the capacity assessment document. UN agencies can apply if they demonstrate that there are gaps that NGOs cannot cover. The allocation paper outlines the details of the JHF fund. Technical committee to be setup at the level of the BNWG will consist of NGOs who did not submit a proposal for JHF fund. BNWG Geographical gap analysis will be shared to direct partners to priority areas. Projects with qualifying score will be review by GenCap Advisor for gender marker. OCHA will communicate to NGOs the feedback on all projects.
Presentation from ECHO consortium	<ul style="list-style-type: none"> ECHO consortium (Intersos, ICMC, NRC and Save the Children Jordan) presented the findings from the post distribution monitoring (PDM) of their winterization intervention in support of the most vulnerable Syrian and Jordanian families living in camps and non-camps settings. Presentation from UNWOMEN	<ul style="list-style-type: none"> UN Women presented on its Cash for Work (CfW) Program Monitoring highlighting a need to gender empowerment in accessing work in camps settings. General reminder on reporting (Activity info, RAIS, winterization).	<ul style="list-style-type: none"> The deadline for reporting March activities is 8 April. <u>Sector co-chairs emphasized the need to report retroactively on Jan and Feb activities if it is not accurate, yet.</u> RAIS bulk upload is available and should be used to enable a case-by-case comparison of assistance delivery. Partners were also reminded to finalize their winterization reports as agreed on the last BNWG meeting.
