Adoption of minutes of the last meeting/ new points of action

The minutes of the last meeting were adopted by all partners present in the latest meeting. Discussion still ongoing concerning the NFI stock compilation on NFI availability by all partners in the region. As this point in the agenda has not yet been completed, the NFI WG considered as a better idea for the WG to:

- 1. Share and compile what has been distributed in all the sites so far by all actors.**
- 2. Also, share and compile what all actors active in this field have planned for the upcoming 4 weeks (mass distributions- targeted distributions/ location/ items/ date of implementation)**

- 3. Create a standard list of NFIs, similar to the one used and shared in the WASH SWG → Actors that participate in also in the WASH SWG to share this list with us as an example.** All WG members are kindly asked to provide their feedback on list of items and standards.

Communal Kitchen

A sub-working group on communal kitchen draft plans and design has been established on a national level. Please see attached the files on the communal kitchen. Actors interested in the project are kindly asked to also provide their comments/feedback on the project for the North.

NRC informed the NFI SWG that according to the Thessaloniki Fire Department, the law on restrictions on fire from 1st of May and onwards, applies only to open fires.

DRC has been discussing the communal kitchen project with MoMP in the North and informed the WG that MoMP would like the communal kitchen project to be applied in all the sites in the North equally in order to avoid it becoming a push/pull factor for specific sites.

Food distribution, provision of fresh cooking material and food containers are aspects to be taken into consideration for the communal kitchen project.

Summerization

UNHCR technical team has been working on assessment for summarization in the site in Northern Greece. Updated on this issue are to be shared with the WG as soon as available.

IOM, DRC and NRC are interested in supporting this project.

Safe boxes

NRC informed the partners that population in various sites are requesting for safe boxes. Partners that could possibly provide this can share their suggestions with the WG.
