4. Code of Conduct (CoC) for Volunteers

Code of conduct produced by the volunteers in Ritsona presented to group. Agreement to try to develop a standard CoC with this as a base. DRC has experience with this from Lesvos and it was agreed that that based on the Ritsona CoC and input from the Group DRC will come up with a draft for next meeting. The draft will then be discussed with the group and then shared with the other sectors for input.

Points that was raised by the sector as important to include:

- No proselytism
- No photo/video in the camp
- Protection of children from being taken out of the site
- No tourism
- Protect privacy of PoC

5. Partner update

- Solidarite: New CCCM person, Maan Hilal, in country
- DRC: Started officially in Skaramagas on Monday
- IOM: Will be involved in the Pre-registration exercise
- Salvation Army: Starting up Greek lessons around Victoria Sq
- UNHCR: Pre-registration exercise will start by the end of May. It could still me moved a bit, but the plan is that the training will start 23rd May and pre-registration 30th May. The team in the North will start in Oreocastro. And in the South in Eliniko.

6. Communal Kitchen presentation

Phoebe Goodwin from the Shelter/NFI working group presented the work so far on communal kitchens. An updated version of the presentation will be shared with the working group early next week. The working group agreed to provide feedback in the next meeting. Especially of how families can share the kitchen facilities in a fair way is an issue SMS input are asked for.
