



## How UNHCR coordinates its refugee response in the Far North

In line with UNHCR's responsibilities to **ensure efficient, predictable and accountable** coordination for refugee protection and response, it has set up coordination mechanisms at sub-national level, i.e. in Maroua and at national level, i.e. in Yaounde for Nigerian refugees in the Far North. The set-up of the coordination structure for the Far North is guided by the following principles:

- ✓ The **Government of Cameroon** assumes **primary responsibility** for refugee protection and UNHCR supports rather than substituting the Government's Line Ministries
- ✓ Focus for **coordination** is put at the **point of delivery**, i.e. the field, while limiting meetings at national level to questions such as overall standard setting and policies as well as advocacy which requires national involvement
- ✓ **Participation of refugee representatives** in the coordination meetings is ensured, e.g. at the CCCM meeting
