



KEY HIGHLIGHTS



Country Programme Development: UNFPA focused on developing the 2017-2020 Country Programme, which takes into consideration the resilience approach across all agreed-upon outcomes, outputs and strategies of intervention.



Annual Review Meetings: UNFPA held Annual Review Meetings with its 2015 implementing partners in order to assess achievements, challenges, lessons learned of the past year, as well as discuss jointly modalities to scale up interventions and enhance delivery of results. These meetings resulted into concrete recommendations for the 2016 implementation.



Study on General Awareness on Family Violence Law in Lebanon: Two years after the law against family violence was passed, IPSOS study supported by UNFPA and KAFA (Enough Violence & Exploitation) showed that 44% of the interviewed Lebanese community members personally know survivor(s) of domestic violence and that 68% would interfere if witness of a domestic violence incident, against 32% who would not, mainly as they consider family violence as a private matter. While 77% (including 84% females) are aware of at least one organization providing services to survivors, only 32% are aware of the new law on family violence in Lebanon, and only 14% of the protection orders. Building on these essential findings, UNFPA continues its partnership with KAFA to raise more awareness on the domestic violence law and support the implementation of its various components.



Generating Evidence on Sexual and Reproductive Health to Identify Potential Gaps in Services: The assessments carried out including Post-Partum Family Planning Counselling and referral for Emergency Obstetric and Neonatal Care (EmONC) showed poor family planning services after a woman delivers at hospital as well as inadequate referral mechanisms to EmONC. Moreover, a national mapping exercise carried out showed that around 150 doctors as well as 200 midwives and nurses are interested in receiving training on sexually transmitted infections (STIs) syndromic management. Based on the above findings, UNFPA is partnering with the Ministry of Public Health, National AIDS Programme and Order of Midwives among others to respond to critical gaps within family planning services at primary and secondary health care levels including capacity development.

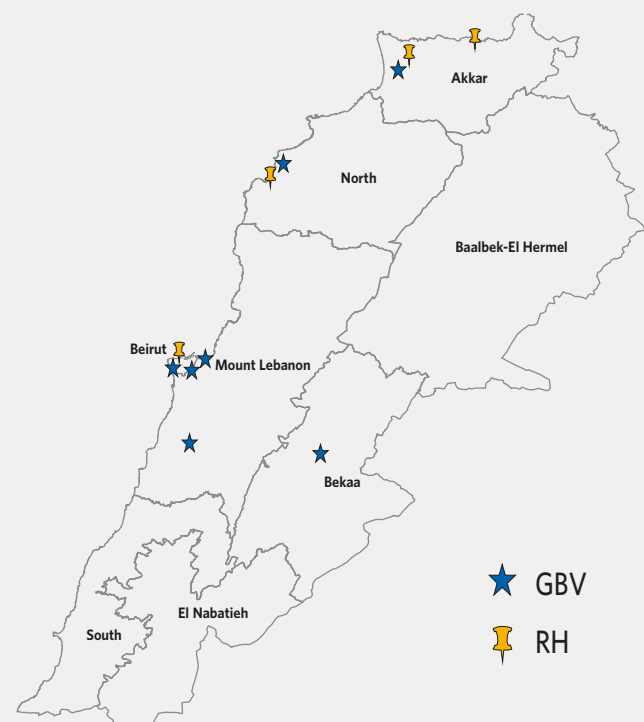
