- -MoED staff, should be trained staff on how to treat and deal with refugees (humanitarian induction)
- -lack of interpreters to break the language barrier
- -the need for support staff (social workers/ psychologists
- -the afghani children to be included to prevent different schooling conditions (a population more likely to remain and in more need for integration)
- -modalities on how to assist refugee families enrol their children in formal morning education classes.
- -teachers selection procedures and criteria should be experience in intercultural education and possibly examin the possibility of hiring refugee teachers with the needed qualifications.
- -regular meetings between parents/teachers committees (as in some locations currently on regular basis, like in Exohi,the regular meetings of Apostoli with the parents) where monthly performance reports are shared with the parents
- -common activities for the children attending afternoon classes with the greek children children are important integration process (athletic, cultural activities)
- -if the MoED and the Greek government are going to extend the age of complosary formal education from 15 to 18 refugee children at the same age group should be included with an adequate support so those of them who wants can access university education
- -competency exames should be the criteria to decide in which classes the children are enrolled and not only the age to ensure that children with higher competencies are in adequate classes.
