

DRC Complaint Response Mechanism	OCHA High Delegation Visit
<p>During the Month of February DRC CCCM receive three formal complaint letters from KNP, two of which were complaints about INGO agencies salaries and poor quality staff, of both Education and WASH facilitators. The final complaint was regarding the single housing. Contentious issue in KNP, as there are many IDP who refuse to accept the single house and wish to be re-housed at their place of origin.</p> <p>DRC is highly committed to listening to the IDP communities we serve and to international commitments on accountability; as a result DRC CCCM will be focusing on improving our Complaint Response Mechanism (CRM) over the coming months. Throughout the month of March we will be holding focus group discussions with our camp based staff and IDP communities for their input on how best to improve our CRM system. Updates will follow in next month's report.</p>	<p>DRC CCCM was grateful to facilitate the visit of John Ging, Director of Operations for OCHA, to KNP camp at the end of February. He expressed concerns at the collapsing shelters, poor sanitation, poor access to health services, all of which he expressed in a OCHA press release in New York.</p>

Cross-Cutting Issues
Most IDPs have not accepted the single houses as they do not trust the government to assist them to return to their home of origin if they accept the house. There is a lot of confusion within KNP regarding the implication for their access to services if they refuse the single house.
