Camp Coordination and Camp Management Agency - RSG, UNHCR and LWF	<ul style="list-style-type: none"> Conducted CMC meeting, participated 51 (18 women) representatives from CMC, incentive workers and camp based committees and discussed about burning issues and analysed responsible actors for the solution on 10 February. Conducted Incentive Workers capacity development training, oriented communication trees for information collection and sharing, reporting, family profile survey, participated 20 (8 women), jointly at Khaung Doke Khar 1 camp on 17 February. Supported stationary kits to CMC office on 17 February. Camp Level Inter-Agency Coordination Meeting was held on 24th February and participated by 53(23 women) representatives from Plan, SI, SCI, CMC, FMC, LWF, ACF Incentive Workers, and camp based committees. In the meeting agencies updated their activities and discussed on concerns of agencies and community. LWF presented block systems such as total HHs divided by IWs, name block 1 and manage their blocks to meeting audiences, initiated by CCCM, LWF. LWF CCCM supported communication and coordination, top up card, to CMC and Incentive Worker In-Charge for the month. HH verification survey were conducted during the month and verified by CMCs and IWs. Data entry work in progress. 4 (3 girls) babies were born and 1 woman died for sickness during the month and updated population dashboard. IWI updated activity dashboard during the month.
