<b>Camp Coordination and Camp Management</b>	<ul style="list-style-type: none"> <li>LWF organized sports events (Cane ball, Tug of War, Football, and Running, See Hto) in the camp jointly with Department of Health, RSG on January 13 and 14. In the events 357 (164 girls) youths and children from IDPs and Host communities participated and enjoyed the events.</li> <li>LWF facilitated a CMC meeting on 15 January and discussed on different social and humanitarian assistance issues where 30 (10 female) participants from different groups (CMC, Women Group, Teachers, etc) participated and discussed.</li> <li>LWF facilitated an Inter-Agency meeting on 26th December where 32 (9 Female) representatives from CMC, ACF, LWF, Women Group and Youth Group participated and shared updates, discussed concerns and issues and shared the plan for next month.</li> <li>There were 9 (4 baby girls) new born babies in the month of December. One death was reported in the month.</li> <li>LWF installed complaints and response mechanism (CRM) IEC materials in a public place and briefed about the message.
