<p>Jordan Response Plan 2018-2020: Eddie Dutton, UNESCO briefed partners on the latest progress of JRP 2018-2020 post Dead Sea workshop held on 24-26 September 2017.</p> <ul style="list-style-type: none"> Comprehensive Vulnerability Assessment (CVA) is at final draft pending approval by MoE. Sector Narrative has been drafted pending approval of Task Force membership of Education JRP. Partners are welcome to review it but to pay attention on wording limitation outlined by MoPIC. Project Summary Sheet (PSS) of Education for 2018 JRP was reviewed by Task Force of Education JRP. The Secretariat of Education JRP is currently cleaning it for quality assurance to be reviewed the Government of Jordan. As of 09 October, ESWG has compiled USD 142.4 million financial requirements received from 29 organizations (26 INGOs and 3 UN) under the component of Resilience (USD 76.7m) and Refugee (65.7m). Next step is to undertake these following actions between October and November or early December 2017. <ol style="list-style-type: none"> To finalize sector narrative and PSS, Submission by MOE to MOPIC, To update based on Government's feedback, The official launch of the JRP in end of Nov/early Dec. 	<ul style="list-style-type: none"> Partners are still given time to submit their financial requirement for JRP 2018-2020 by the Thursday, 12 October 2017. Partners are requested to review the final narrative draft of Education Sector Response Plan and send their inputs by latest CoB, 12 October 2017. The presentation of Mr Dutton to be shared with all partners.
<p>Learning for All 2017-2018 Campaign (L4A): Fatima AlMughrabi, UNICEF presented key updates of L4A 2017-2018 with following points:</p> <ul style="list-style-type: none"> Advocacy: The official circulars were issued by the Government of Jordan to allow every child to register without any documentation. Other nationalities registered as refugees under UNHCR are free from paying school fees. Total reach: Out of 118,514 children reached, 15,915 are out-of-school. They have been referred by partners to either public schools, Catch-Up or Drop-Out center. Out-of-school children (OOSC): Partners are requested to refer any OOSC to either formal or certified non-formal education across Jordan including children with disabilities. Deployment of school facilitators: UNICEF with the approval of MoE deployed 240 Jordanian school facilitators and 217 Syrian volunteers to facilitate the registration and data collection of children in 206 double shift schools. 	<ul style="list-style-type: none"> Coordinator to link non-UNICEF PCA partners and UNICEF to involve them for 2018-2019 L4A campaign. Coordinator to share the list of Catch Up and Drop Out centers, Double Shift School as well as school with resource centers for children with disabilities managed by Mercy Corps. MoE, UNICEF/Questscope to present Drop Out program in November ESWG meeting. The L4A presentation of Ms AlMughrabi will be shared with all partners.

<ul style="list-style-type: none"> • Partnership: It was agreed that non-UNICEF PCA partners will be involved in 2018-2019 L4A campaign to scale up the reach of OOSC to access education pathways. 	
<p><u>Any other Business (AoB):</u></p> <ul style="list-style-type: none"> ➤ Sector performance: ISWG led by UNHCR is currently conducting sector performance survey.
