Inclusion of Gender Equality Components in the Sectors' Work Plans

- The SGFPs are recommended to ensure that the sectors' work plans include gender equality components, and then regularly follow up on implementation. The FPs are encouraged to share on the challenges and achievements with the network members.
- Protection, SGBV and Child Protection (CP) sectors are finalizing Capacity Development plan, which includes gender mainstreaming. The sector gap analysis is at the completion stage.
- The 2018 work plan of Education sector is not developed yet. The 2017 plan included gender mainstreaming. The sector gender analysis of 2016 is being revised, and is expected to be finalized in July 2018.
- WASH sector highlighted importance of reviewing sector gender analysis.
- Livelihoods work plan is being finalized, incorporating comments from the sector members.
- The following challenges were indicated:
 - o Coordination and communication at the sector level and between SGFPs of the same sector;
 - o Time allocated for the FPs' functions in addition to the regular role at the agency;
 - Acceptance of the agencies / supervisors the efforts their staff favor to the network;
 - o Reluctance of sector members to self-delegate for SGFPs' roles;
 - o Understanding of SGFPs of their role, particularly utilizing sectors' platform to promote gender equality.
