## Refugees elect new representatives in Lóvua, Lunda Norte.

#### Introduction

On 27 March 2018, hundreds of Congolese refugees living in Lóvua settlement in the Angolan province of Lunda Norte voted to elect their representatives. This was part of a comprehensive process that included an awareness campaign and a three-day election.

### Context

In 2017, political and military instability in the Kasai region of the Democratic Republic of the Congo (DRC) forced more than 35,000 people to seek refuge in Lunda Norte Province. Most of these refugees now live in a large settlement in Lóvua municipality.

#### Reason for the election

Refugee voices are important for the work of UNHCR, humanitarian actors and the host community. In this context, after a consultation with approximately 500 refugees in October 2017, each village elected a three-person committee that included a Representative, a Vice-Representative, and a Secretary. Each committee includes at least one woman. As a result, some 200 refugees were selected as candidates for the elections.

The preparation for the elections was part of a larger campaign called "More of Listening" that included the dissemination of detailed information in local languages, and peaceful coexistence between elected officials and the population. To achieve these goals, an inter-agency taskforce organised village meetings and information sessions on the election process as well as on the objectives of the leadership structure.

On 27 March 2018, the elections were managed by UNHCR, Médicos del Mundo (MdM), World Vision (WVI) and Jesuit Refugee Service (JRS) with the aid of refugee mobilisers. Government entities such as the Ministry of Social Welfare, Family and Female Empowerment (MASFAMU) also participated to monitor the election whilst the police ensured the security of the process and of the vote counting exercise. Congolese refugees were happy to have the chance to vote and there was dancing and singing.

## **Election results**

On 12 April 2018, UNHCR and partners announced the election results. Out of an eligible 4,728 refugees, 3,524 voted which resulted in a voter turnout rate of 74%. Some villages recorded an impressive 100% voter turnout. 1,620 women voted, representing 35% of the voters.

## **General Assembly**

On 18 April 2018, a general assembly was held with all new refugee representatives, UNHCR and partners as well as representatives from the police, MASFAMU, and agriculture, to explain the Terms of Reference (ToR) for the elected positions and introduce the elected leaders to all partners.

Kandolo plans to develop training on livelihoods and values that he hopes will serve them both in Lóvua and in the DRC should they decide to return voluntarily. Kandolo also spoke about the importance of working with

partners to solve potential problems that may affect the wellbeing of the Village.

Representative Barron would like to improve employability for residents of his Village. Tshibola Ndambi focused on fighting against tribal tensions.
