

Notes:

- 1. The financial requirements for West Africa are for the operations in Benin, Burkina Faso, Côte d'Ivoire, Gambia, Ghana, Guinea, Guinea-Bissau, Liberia, Mali, Niger, Nigeria, Senegal, Sierra Leone and Togo.
- 2. The percentage funded is calculated using earmarked contributions pending the eventual allocation of broadly earmarked and unearmarked contributions.
- 3. Contributions are shown by the level of flexibility in the earmarking. Contributions earmarked to a situation within a country are classificated as country level.
- 4. The broadly earmarked contributions listed are those which can potentially be used for West Africa due to their earmarking to a related situation or theme, or to the region. The total amount of the contributions is shown for donors who have contributed \$2 million and more.
- 5. The total amount of unearmarked contributions is shown for donors who have contributed \$10 million and more.
