


# BURUNDI REFUGEE RESPONSE PLAN FUNDING (JANUARY- DECEMBER 2018)

# **Highlights and Operational Context**

- The Ebola outbreak in the Democratic Republic of Congo (DRC), home to 43,010 Burundian refugees, remains dangerous and unpredictable with the community surveillance exercises being hampered by armed group activity in the North Kivu area. A strong partnership between UN agencies, the UN Stabilization Mission in the DRC, government authorities and other partners have so far prevented Ebola from spreading to other areas in the country, including refugee camps, as well as into neighbouring countries.
- The Burundi Regional Refugee Response Plan for 2019-2020 was published in late December 2018, and calls upon donors to address the most underfunded refugee crisis in the world, and to continue supporting the host countries. The Burundi Regional RRP appeals for US\$ 296 million in 2019 in a collective effort of 35 partner organizations supporting host governments to provide protection and assistance to Burundian refugees in the region.
- The Special Envoy of the UN Secretary-General for Burundi, Michel Kafando, during his address to the Security Council on the 21<sup>st</sup> November, highlighted the need to strengthen "the trust and dialogue between the Government and the opposition parties, which is essential for the resolution of the ongoing crisis." Mr. Kafando also stated the pivotal role played by international and regional bodies such as United Nations, East African Community and African Union towards the re-evaluation of their commitments to support Burundi.
- On 21st November 2018, the Regional Child Protection Network held an information sharing session on "The critical importance of child protection in refugee situations," held as part of the International Day of the Child. The session brought child protections partners together with donors to promote a regional overview of the protection situation of refugee children affected by the Burundi crisis as well as highlighted some of the responses, gaps and challenges faced.
- The Regional Refugee Coordinator for the Burundi Situation undertook a joint mission with UNICEF to Rwanda from 19-22<sup>nd</sup> November 2018. The mission included a review of the progress made in the implementation of the Comprehensive Refugee Response Framework (CRRF) in Rwanda and explored areas for collaboration in supporting the Government to include refugees in national systems and services.
- On 17-18<sup>th</sup> December 2018, the East African Community (EAC), Technical Working Group on Refugee Management held a meeting, jointly organized with UNHCR towards the development of the EAC Policy on Refugee Management. A regional refugee policy would be a stepping stone towards the harmonization of national laws and policies on refugee matters and provide an opportunity to endorse the goals and principles of the new global Compact on Refugees at the regional level.



# Update on voluntary repatriation of Burundian refugees from the United Republic of Tanzania

#### **Background**

- UNHCR and partners are not promoting return to Burundi, but are working with the governments
  involved to ensure that returns are based on the principles of voluntariness and informed decisions,
  and take place in safety and dignity.
- The current return operation is taking place under the framework of a Tripartite Agreement between the two governments and UNHCR in which all parties have acknowledged that while some refugees may opt to return now, others may still have well-founded reasons not to return at the present time and will continue to be in need of international protection.

#### **Update**

After being halted throughout October 2018 due to the suspension of international NGO activities, assisted voluntary repatriation restarted at the beginning of November 2018 when several UNHCR partners received the go ahead to resume their operations. As of 31st December 2018, 84 foreign NGOs have been authorized to resume operations in Burundi after indicating adherence to the 2017 regulations governing NGOs presence and work in the country. This authorization ended the 3 month notice period for foreign NGO to comply with the new regulations.

#### **Partners**

- In the United Republic of Tanzania, UNHCR and the Government of the United Republic of Tanzania work in partnership with the Danish Refugee Council (DRC), HelpAge International, International Committee of the Red Cross (ICRC), Tanzanian Red Cross Society (TRCS), International Federation of Red Cross and Red Crescent Societies (IFRC), International Organization for Migration (IOM), Plan International, and the World Food Programme (WFP).
- In Burundi, UNHCR is collaborating with the Department of Repatriation under the Government of Burundi, World Food Programme (WFP), International Rescue Committee (IRC), Caritas and the Civil Volunteer Group (GVC).



### Achievements during the Reporting Period

#### **TANZANIA**

#### **Latest Developments**

- To ensure consistent and effective dissemination of information to refugees, a number of inter-agency communications and information needs assessments were conducted in Nduta, Mtendeli and Nyarugusu camps. The findings enabled the identification of refugees' preferred communication channels and trusted sources of information, as well as existing communication gaps, and will be used to inform efforts to empower refugees to make decisions at all levels.
- On 4<sup>th</sup> and 7<sup>th</sup> December, respectively, the common markets in Nduta and Mtendeli that had been closed down as part of a series of restrictive economic measures put in place in late July were re-opened, following sustained advocacy by UNHCR, partners and local communities. The common markets will be open once a week for the time being, although it is hoped the frequency will increase.

#### **Achievements and Challenges**

- A total of 14 Burundian students who passed the Albert Einstein German Academic Refugee Initiative (DAFI) scholarship selection process have enrolled at the University of Dodoma, in Tanzania.
- General food distribution (GFD) was maintained at 100% of the full basket in December. Refugees received 100% of cereals, pulses, vegetable oil, corn-soya blend and salt entitlements for the second month in a row.

### RWANDA

#### Latest Developments

UNHCR high profile supporter, model and photographer Helena Christensen carried out a visit to Rwanda in November and called for support to the world's most underfunded refugee crisis, the Burundian crisis. Rwanda hosts some 149,520 refugees and asylum seekers, including 69,423 refugees from Burundi which represents 46 per cent of the total refugee population in the country.

#### **Achievements and Challenges**

While 6,907 constructed semi-permanent shelters are hosting 100 per cent of the camp population, 1,717 semi-permanent shelters still require plastering works/mudding to enhance their durability. Meanwhile, 21 semi-permanent shelters had their doors and roofs repaired and maintained through community participation.



Daily hygiene promotion activities and community participation were conducted in all communities reaching 57 per cent of camp population (33,383 individuals) to increase awareness of best hygiene practices.

#### DEMOCRATIC REPUBLIC OF THE CONGO

#### **Latest Developments**

 On 30<sup>th</sup> December 2018, elections were held in the Democratic Republic of Congo (DRC). No major population movement has been reported into countries neighboring DRC.

#### **Achievements and Challenges**

- In Lusenda camp, the cholera treatment units at the health centre were rehabilitated by UNHCR and its partner ADES, and in Mulongwe settlement a rehydration point was built as part of cholera prevention measures. They benefit both refugees and the Congolese host population.
- 12 hectares of land were allocated to 192 refugee households in Mulongwe settlement by the local community in support to agricultural activities and to foster both peaceful coexistence and self-reliance. Refugees were also given agricultural tools and seeds to facilitate their farming activities.
- In November, 26,567 Burundian refugees received biomass briquettes in Lusenda camp, and 4,356 received firewood in Mulongwe settlement as part of the efforts to ensure Safe Access to Fuel and Energy (SAFE) to refugees and address environmental concerns.

#### **UGANDA**

#### **Latest Developments**

- A task force was established by the Inter-Agency Coordination Group and Sector Co-leads, to prepare the deployment of Activity Info in the first quarter of 2019. Activity Info is an online information management system, conceived to monitor the implementation of the 2019-2020 Refugee Response Plan through partners' activity mapping.
- As per the Memorandum of Understanding (MoU), UNHCR handed over the data of Persons of Concern (PoCs) verified in Uganda to the Office of the Prime Minister (OPM). The data collected entailed significant joint efforts to ensure the standardization and harmonization of the registration processes in Uganda.

#### **Achievements and Challenges**

UNHCR, academia, and partners supported Ministry of Health to review the 2016 protocol for the Integrated Management of Acute Malnutrition (IMAM). The review paved way for the new 2019 national IMAM guidelines, taking into account the Uganda refugee context, which will strengthen the existing practice in the management of acute malnutrition nation-wide.
