General update

The CCCM partner trained 24 fire wardens from Garowe and Burtinle IDP sites. The fire wardens are responsible for sensitizing site residents to fire hazards, fire prevention and response strategies. The training equipped the participants with the tools and knowledge needed to promote fire safety within the sites and curtail damages that may occur from fire. The knowledge acquired can be cascaded down to household level so that the community is able to properly respond to fire and mitigate its risk and devastating effects.

CCCM Cluster partners worked with local authorities to secure an alternative land to 49 Households who were evicted in Kismayo. CCCM partners prepared the land prior to the arrival of the new residents to ensure that it was suitable for relocation.

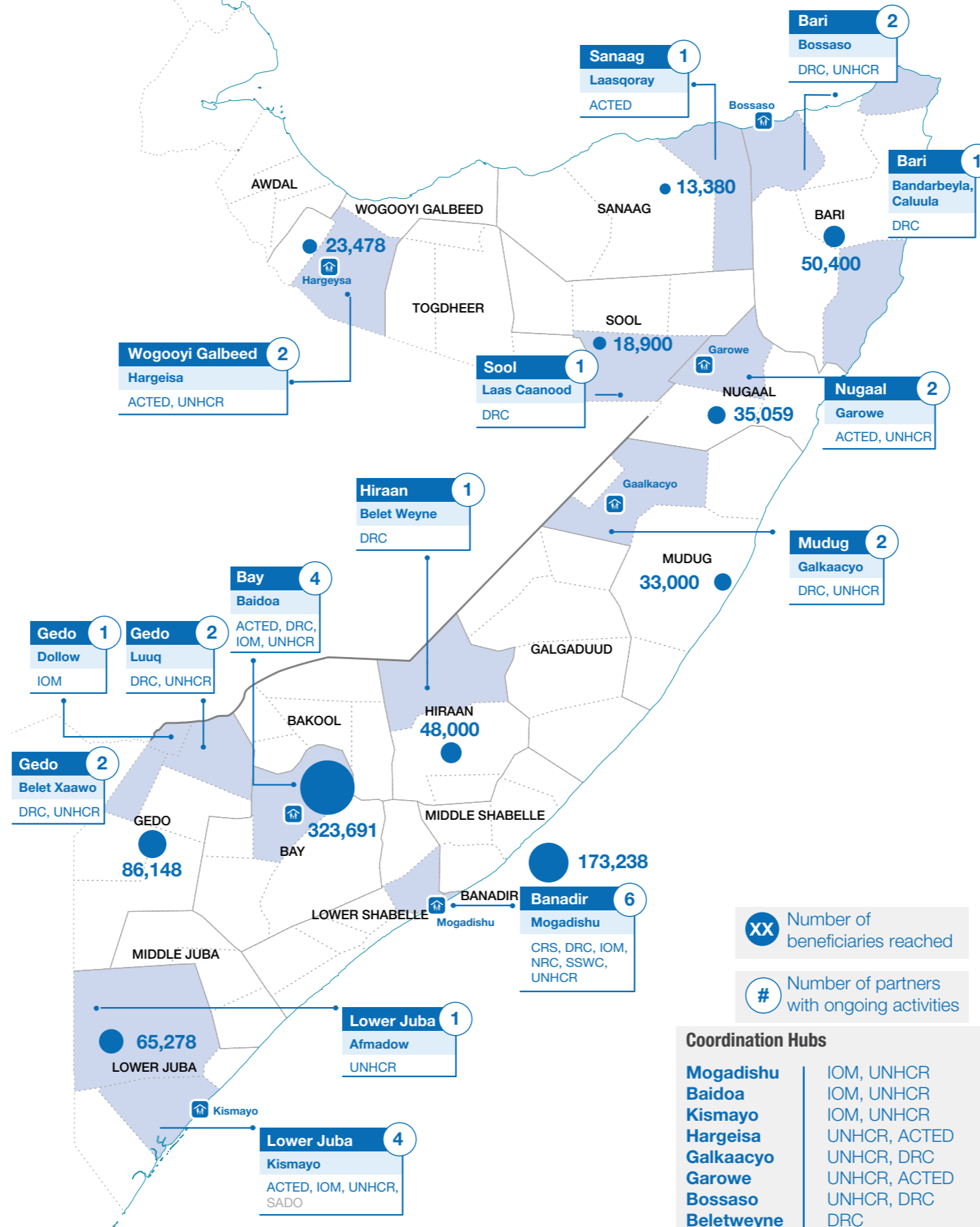
Community solar lights were installed in 32 sites in Galbeed IDP sites in Kismayo. This communal lighting is an essential public service that provides a safer environment and intends to reduce GBV incidents in IDP sites.

CCCM Partners in Kismayo conducted a Safety Audit workshop to present findings from the latest Safety audit conducted in Galbeed sites in December 2018. The workshop was attended by 24 participants coming from 13 different UN Agencies, NGOs and Lower Juba local authorities departments. During a participatory group work, participants were divided in groups based on their sector of operations and collectively drafted the recommendations to address main findings collected during the exercise.

CCCM partners in Dolow replanned a block of Qansaxley IDP camp to improve congestion and access to services for residents. The team allocated plots to 65 new households who have arrived this month.

Site development of the Baidoa public site is ongoing with an aim to be finished by the end of March. Two taskforce meetings were conducted with partners and local authorities to coordinate the process.

- Low levels of community participation and AAP inhibit ability to improve beneficiary targeting to include marginalized populations
