RESPONSE FOR VENEZUELANS

#### Situation

- In Aruba, Curaçao, the Dominican Republic, Guyana and Trinidad and Tobago, public health regulations and movement restriction measures continued in April due to the impact of the COVID-19 pandemic, resulting in the loss of livelihoods and heightened vulnerability for Venezuelans and the host population. Unemployment, increments in pricing, food insecurity, threats of eviction, and access to healthcare were reported as the main concerns throughout the sub-region. Remote modalities of working and physical distancing protocols remained enforced for R4V partners.
- The numbers of COVID-19 cases in the Dominican Republic increased, causing an extended state of emergency and a reduction of livelihood opportunities.
- The negative impact of travel restrictions on Aruba's tourism-dependent economy led some 400 Venezuelans to register for voluntary return to Venezuela on the

Department of Integration and Management of Foreigners' website. R4V Partners requested that the Aruban Government provide clarification on conditions and required documentation that apply to these returns. As of 30 April, no return had taken place and discussions between the Governments of Aruba and Venezuela continued.

- Trinidad and Tobago local press reported arrests of Venezuelans, including minors, at unauthorized social gatherings labelled "COVID-19 parties". Unfavorable press coverage and potential recourse to negative coping mechanisms in facing employment losses continue to be of concern.
- On 24 April, in compliance with an order by the Supreme Court, the Guyana Elections Commission approved a 25day operational plan to carry out the recount of all votes cast at the 2 March General and Regional Elections.

### Response

- R4V partners continued to provide direct emergency assistance in the Caribbean subregion to Venezuelan refugees and migrants. The type of direct emergency assistance provided to those in vulnerable conditions included mainly food and non-food items (NFIs), shelter, cash-based interventions (CBI), health assistance and protection support. The lack of formal and informal job opportunities in host countries exacerbated by the COVID-19 pandemic, had a significant impact on host populations' and Venezuelans' ability to be self-reliant and to improve mental well-being.
- With food insecurity on the rise across the subregion, R4V stepped up their interventions, providing food assistance to 124 Venezuelans in the form of food vouchers and food baskets in Aruba. In Curaçao, a government initiative led to the creation of a food distribution network which was

coordinated by R4V partners. The efforts reached 1,739 beneficiaries from the Venezuelan and host populations. In **Trinidad and Tobago**, R4V Partners prioritized **food assistance** to 345 Venezuelan families. Direct deliveries of food packages and food vouchers were conducted with the assistance of community groups who aided in transporting **food hampers** to remote areas. Separately, partners approved two quick impact projects with local NGOs to aid in rapid food distribution. In the **Dominican Republic** and **Guyana**, food assistance reached 1,726 Venezuelan refugees and migrants.

 As part of their emergency support, R4V partners provided different forms of temporary accommodations and emergency shelter. In the Dominican Republic, 95 refugees and migrants benefited from support with rental accommodation. Alternatively, in Curaçao partners provided short-term temporary housing solutions to 4 Venezuelans, while short term lodging at hotels was provided to two Venezuelans in the Dominican Republic.

With remote working modalities and physical distancing protocols in place, the use of CBI increased in the subregion. Multi-purpose CBI reached 122 Venezuelan migrants and refugees in Aruba, while in the Dominican Republic, it was provided to 206 Venezuelan refugees and migrants in the form of vouchers and cash. Of the 206 beneficiaries, 56 were adult males, 80 females and 70 children. In Trinidad and Tobago, R4V partners reviewed the criteria for administering multipurpose CBI to include COVID-19 impacts (criterion to be added to other CBI SOPs across the subregion) and aided the most affected families with very limited resources. Sixty-three individuals including 59 Venezuelan refugees and migrants were assisted. Non-Food Items (NFI) kits, including COVID-19

**kits** and cash vouchers were also distributed to 254 Venezuelan individuals, including 88 adult males, 78 adult females and 88 children in **Trinidad and Tobago**. Whereas in Guyana, 720 Venezuelans benefited from the distribution of **NFIs**.

- Activities to promote access to health were also conducted in the Caribbean countries. R4V partner health clinic provided emergency health services to 165 Venezuelan beneficiaries in Curaçao. The same clinic provided Primary health care services for 402 refugees and migrants from Venezuela both by 'remote' and 'in-person' modalities. Secondary health service consultations, including the prevention of HIV/AIDS were also provided to two Venezuelans. In the Dominican Republic, 31 persons received primary healthcare assistance.
- To ensure the protection of Venezuelans, partners continued providing protection assistance mainly via remote modalities during the month of April. In Aruba ,168 Venezuelans received case management services, while 87 refugees and migrants from Venezuela received protection services via Hotline Non-Case Management services set up by R4V partners. In Trinidad and Tobago, one partner provided safe shelter to 4 Venezuelan victims of trafficking and at-risk refugees and migrants. As for detention cases, one R4V partner followed up by providing legal assistance to 18 individuals.
- In Guyana, protection activities continued with capacity **building** to develop protocols and referral pathways for 12 local frontline service providers. Additionally, 17 at-risk Venezuelans were provided with counselling services regarding legal rights and available services. Furthermore, 249 refugee and migrant children from Venezuela received specialised child protection services (prevention and response to violence) through the efforts of one R4V partner. In the **Dominican Republic**, one partner provided remote psychological support to 8 Venezuelans. Legal orientation during biometric registration was also provided to two Venezuelans. In addition, partners provided specialized legal assistance to 61 Venezuelan refugees and migrants in the Dominican Republic and Trinidad and Tobago, bringing the total to 63 persons having received legal services.
- In order to guarantee the right to education during the pandemic, R4V partners in Trinidad and Tobago maintained educational services to Venezuelan children, moving their educational offerings to 100% online modality. Education teams adapted online teaching methodologies, curricula and interventions, and provided additional support, including the provision of tablets to 324 Venezuelan students.
