Introduction new Coordinator

The WHO Representative for Armenia Egor Zaitsev introduced Chris HEPP to the partners as the Health Technical working Group Coordinator.

In his response from Chris, gave a brief background of his experience in the humanitarian sector. He then entreated members to participate fully in the meeting and other activities of the health working group.

Update from the Ministry of Health

Dr. Gabriel Tepelikyan provided an update from the side of the Ministry of Health.

- No major changes and there have been a slight decrease in the daily cases.
- Efforts are being made to prevent new entry of the new strain of the covid -19 into the country.

- Continue collaboration with WHO and partners to support people living in refugee like situation especially in the effort dealing with COVID 19 pandemics as well as responding to the heath needs of persons living in refugee like situations.
- Armenia is in the process of procuring COVID 19 Vaccine.

Presentation on the Inter-agency Response Plan (IARP)

Ms. Denise Sumpf, Head of RCO & Senior Development Coordination Officer, presented an overview to the Inter – Agency response plan.

Highlights

- Possible through the contribution of all partners through the thematic working groups.
- A total budget of \$62mil
- Health component of the budget was a little over \$6mil

Partner Updates

World Health Organization (WHO) response to the people living in refugee – like situation.

- Provided 20 NCD kits to the ministry of Health to support the people living in refugee –
 like situation as well as the host communities? Each kit is enough to treat 10 000 persons
 for 3months.
- WHO will further engage with the MoH to identify additional needs to fulfil the needs of people living in refugee like situation?
- Reporting: reporting requirement for health partners.
 - Biweekly situation report: required to highlight the activities of the health working group to members of the
 - 3/5 Ws reporting: review of the template underway and members will be required to submit data monthly.
 - Contact list: members were urged to update their list of contact in other to continue receiving update from the Health Technical Working Group.

On a wider scale how, it could fit in existing Information systems of the Health partners and the other Technical Working Groups and overall to support the existing Information System(s) within the MoH.

Fernando HESSE from OCHA speaks about the Readiness Plan for NK which is what we should be aiming at start working soon.
