<b>COVID-19 Vaccine Facilitation Compensation</b>	<ul style="list-style-type: none"> <li>- The Government of Jordan has imposed a defence order in October 2021 that residents of Jordan need to be vaccinated or have a negative PCR test from last 72 hours to enter public facilities including banks/ ATMs</li> <li>- UNHCR in compliance with the Defence order, requires that POC needs to show the vaccination certificate or the show a negative PCR test in order to be able to</li> </ul>

	<p><i>approach registration centres to renew asylum seeker certificate or to access any other kind of service. This was put in place as of January 1, 2022</i></p> <ul style="list-style-type: none"> <li>- <i>In this regard, UNHCR has started providing an incentive aiming at encouraging POCs to get vaccinated. The compensation is to cover the transportation cost and one meal and is 7.5 JOD per vaccinated person. This is only for population living out of camps</i></li> <li>- <i>More than 117,000 individuals have been compensated as they took the vaccine and recently additional 10,000 are entitled to get the compensation.</i></li> <li>- <i>One of the related challenges is that many refugees were using their personal ID number when they registered for vaccination, and this make the process of tracking to compensate from the UNHCR side difficult. <p><b>JRP / 3RP 2022 Planning</b></p>	<ul style="list-style-type: none"> <li>- <i>No official request from MoPIC received yet to launch the JRP exercise for 2022. However, two options to handle the issue are available which are either to rely on what has been provided by the partners for 2022 during the JRP exercise for 2021, since the request at that time was to provide the financial requirements for the next two years (2021-2022). Or request the partners to provide their updated financial requirements (appeal) in all cases to include it in the 3RP and keep it available for JRP.</i></li> </ul>
