Plan for Mapping Members Internal SEA Reporting Mechanisms  Planul pentru cartografierea Mecanismelor interne de raportare SEA a membrilor	<ul> <li>Plan International shared a power-point presentation with a standard example of the SEA Reporting Mechanism for receiving complaints for national and international NGOs. Request for Support in Planning Community Consultations on Inter-Agency SEA Complaints Feedback Mechanism (CFM)  Solicitare de sprijin în planificarea	<ul> <li>The PSEA Network work plan includes community consultations to ensure existing complaint and feedback mechanisms are adapted to the preferences and to the context of local communities, and to ensure they are inclusive and accessible to different populational groups. Among specific objectives of community consultations are the identification of feedback channels that communities prefer and rely on.</li> <li>To advance with this activity, PSEA Network members are encouraged to express their interest to participate on the design and implementation of community consultations.</li> <li>PSEA Network co-chairs will also engage with the AAP Taskforce to promote cross-sectoral coordination.</li> </ul>	UN Agencies and INGOs should encourage local partners to join in on PSEA Network meetings in order to learn more and potentially engage in this initiative  Organizations interested and able to engage in community consultations to email Kristin schmitzk@unhcr.org

Discussion on Increasing Engagement with National Actors  Discuţii privind creşterea implicării cu actorii naţionali	Considering challenges in engaging national NGOs and other local entities in SEA coordination forums, the PSEA Network co-chairs will schedule a specific meeting to discuss strategic efforts for engaging more stakeholders and will work with GBV and CP SWG and AAP TF to encourage participation of their members in the PSEA Network As a first proposal, the PSEA Coordinator suggested a specific forum on SEA for local and national entities starting at the end of July 2022. All present members were requested to invite and ensure an information campaign with their partners and other relevant organizations to engage them in SEA processes/PSEA Network.	Meeting to be held the week of 25/7/22 with exact date to be announced  UN Agencies and INGOs should encourage local partners to join this meeting of national actors and to attend the next PSEA Network meeting on 25/7/22.
	<ul> <li>Participants mentioned the importance of improving awareness raising activities on PSEA and on available complaint and feedback mechanisms.</li> <li>Raise awareness: Information Campaigns on the RCF Inter-Sectoral Green Line (Refugee Helpline) should be implemented for all agencies' personnel and PoCs.</li> <li>Information material: PSEA posters with awareness messages mechanisms are available online and printed. IP Assessment Update Actualizarea evaluării IP	<ul> <li>The RCF is coordinating the mapping of IP PSEA Assessment done in Moldova by UN Entities to verify which organizations have been assessed and which require further capacity building. A total of 53 local organizations have been mapped by the UN in the country so far.</li> <li>The objective of the exercise is to avoid duplication of assessment efforts and to promote coordination by UN entities when developing capacity building plans.</li> <li>Plan International will assess among International NGOs which of them have conducted IP PSEA Capacity Assessment of local organizations based on their own safeguarding policies, and among those who are doing this, map ongoing/planned capacity building plans.</li> <li>This information will be cross-checked with UN IP PSEA Capacity Assessment mapping to ensure INGOs and UN do coordinate the way forward on capacity building plans of partners.</li> </ul>	UN IP PSEA Capacity Mapping: UN Entities who have not yet added information are requested to complete the matrix with the information required by July 22 <sup>nd</sup> .  INGO IP PSEA Capacity Assessment Mapping: UNHCR and Plan will share with INGOs a matrix to recollect information on PSEA Capacity Assessment. Inputs to be shared by July 30 <sup>th</sup> .
