<b>Partner activities alignment with the National Plan</b>	<ul style="list-style-type: none"> <li>The National Plan has 3 measures and 9 activities related to housing:               <ol style="list-style-type: none"> <li>ensuring access of displaced persons from Ukraine, beneficiaries of temporary protection in Romania to unallocated housing, built by the National Housing Agency or by the Social and Necessity Building Programme;</li> <li>ensuring access of displaced persons from Ukraine, beneficiaries of temporary protection in Romania to unallocated housing owned by local public administration authorities, accommodation facilities owned by central public authorities and available private housing units;</li> <li>rehabilitation and/or renovation of unused buildings owned by local public administration authorities, in which displaced persons from Ukraine, beneficiaries of temporary protection in Romania, can be accommodated;</li> </ol> </li> <li>The goal is to align each partner's activities with the National Plan.</li> </ul>	<ul style="list-style-type: none"> <li>Sector Leads to send an Excel file containing the translated measures and activities of the National Plan.
