Current situation	<p>Main figures:</p> <p>912,090 consolidated arrivals, 88,376 in Romania and 823,714 departures. 19,407 under temporary protection.</p> <p>These numbers refer only to Ukrainian nationals.</p> <p>Main Exit Routes (as of 11 May)</p> <p>34% to Hungary (276K) 23% to Ukraine (187K) 21% to Bulgaria (176K) 12% via Air Border (100K)</p> <p>These numbers refer only to Ukrainian nationals.</p>	
Coordination Structure	<p>As some partners slowly begin to transition on early integration activities for those staying in the country, questions were raised on plans for establishing an integration/livelihood WG.</p> <p>As the architecture is finalized now the work is on maintaining regularity while being flexible to adapt to the changing circumstances.</p>	<p>Coordination structure is found on the <a href="#">Inter-agency Coordination Hub</a> and will be revised accordingly.</p> <p>The establishment of new WGs is something to be consider in a dynamic way. I. e. Basic Need WG becoming bi-weekly, and the Anti-Trafficking Task Force being created.</p> <p>Christian Lara taking over the coordination role can be contacted at: <a href="mailto:lara@unhcr.org">lara@unhcr.org</a></p>

	<p>Plans for rolling out light coordination structures at field level is something to consider forward-looking.</p> <p>There will be changes on the coordination role with the end of mission of Oliver Smith. Until his replacement is onboard, Christian Lara will take the Inter Sector coordination role.</p>
