Updated figures and announcements (UNHCR)	 National Plan and RRP was launched at a high-level joint event by the Government of Romania and UNHCR on 26 July in Bucharest. Romania is the only county in Europe to have a NP and sets the standard for others. Having WG's workplans will help in finding the way to interact with RRP and Governments' WGs. RCF did not take place in July due to having the launch, but it will resume at the end of each month. Thanks to those who provided input for the Inter-Agency Operational Update on time; quality of input has improved. Request to use the template for your input. The July report will be shared by Monday and can be used by WGs a reference document. All RRP partner agencies to nominate a focal point for the Activity Info training and RRP. - WG's document which identifies the current priorities and how they interact with the NP:
 - Protection: Workplan and ToR are under preparation, it may take two weeks.
 - Child Protection: Workplan is in place and saved on SharePoint; it complements the NP.
 - Health: No workplan; partners are not contributing and WHO is doing the work of the WG.
 - Education: A mini Education strategy plan is being prepared
 - Basic needs: Identified a cross cutting item which is shelter capacity to absorb the flew of refugees from transit centres to permanent accommodation. Document will be developed to identify the cross-cutting items.
 - PSEA: Since this a cross-cutting issue, the PSEA Network is working with the Anti-Trafficking Task Force to jointly develop an action plan.
 - Livelihood: Employment and access to labour are the crosscutting issues. WG is looking into the language courses and would like to have systematic solutions.
- Regional review of RRP and 2023 version:
 - To be released by September
 - More guidance from HQs will come next week
 - Each country to develop a 3 to 5 pages addendum to summarize the adjustment or reprioritizing of activities and budget
 - Regional Bureau will advise on the process
 - Start the discussion within WGs and send some dot points regarding changes to the RRP
 - Protection WG changed indicators to focus on Persons with Special Needs
 - UNHCR and UNICEF to discuss the suggestion to have Blue Dots at exit points

IAIM: Ahmed will prepare a list for partners and with the support of the Sector Leads reach out to the partners to fill the information for 5Ws. **Service Mapping:** Data collection can be started while waiting on the decision about what tool to use. • Stefane to share a template which will be prepared in consultation with Jorunne for data collection Sectoral updates Livelihood and economic inclusion: (targeted, action-oriented, Informal WG will meet on 4th August as its second meeting activities / gaps) ToR has been prepared The WG will be co-led by UNHCR and IOM • UNHCR Protection is temporarily covering the WG until the new incumbent comes **Education:** • UNICEF has called for a meeting on winterization next week • Those involved in Blue Dots are encouraged to attend **Protection:** Revised the indicators to include persons with specific needs and not only legal issues; revised indicators related to PSEA which are now under the protection sector. • UNHCR and UNICEF are discussing the definition of Blue Dots focusing on types of activities, accessibilities for PoCs, visibility items, revising the list of Blue Dots in Romania (for example some locations in Iasi cannot be considered as Blue Dots). GBV: Had detailed meeting with a GBV partner on training and capacity building plans. Konstantina will take over the GBV until the appointment of new

staff.

• GBV posters are ready and will be shared with Protection WG.

Child Protection:

- May present its workplan during the next meeting.
- CPMS was officially rolled out in Romania last week and the registration of children has already started in the county.

Health:

- Conducted joint WHO-UNHCR-UNICEF contingency/ winterization assessment mission in Botosani county/ 26-29 July.
- Ongoing service provision to Romexpo clinic: from 20 June to 25
 July, a total of 131 patients received primary health services,
 reproductive and sexual health services and psychological
 counselling and emotional support for children and adults.
- Finalized the results of the behaviour and cultural insights study on refugees' health needs, barriers and drivers and shared them with MoH leadership; data was utilized also to inform WHO interview with Politico, as Romania is the 1st country to conduct this type of study.
- Revised the script to produce a video explaining UKR refugees how health system works in Romania.
- Continued dissemination of information materials for refugees, humanitarian workers and healthcare workers in Ukrainian, Romanian, and English languages.
- Conducted the 8th meeting of the WHO led Health WG (20 July) and following up with National Health Insurance House
- Contract signed for the 35 translation devices for FDs and refugees centres.
