<p>Operational updates by members</p> <p>Bahodur Umarov, WFP</p>	<ul style="list-style-type: none"> • <u>ACTED</u> – is currently providing hot meals (catering services) daily in 14 RACs. One RAC is planned to be switched to voucher system starting next week. • <u>HelpAge</u> – continues to support refugees with providing 3 hot meals daily in 25 accredited RACs (22 RACs - catering and 3 RACs - vouchers). • <u>CRS/Caritas Moldova</u>– continues to support 9 RACs. The last weeks they have a constant number of refugees. Vouchers have been distributed in Chisinau on Monday. The next destination is Soroca (2 days) and for the next week – Cahul. 	<p>Activity: To come up with new updates at the next meeting.</p>
<p>Referrals for food assistance outside RACs</p> <p>Bahodur Umarov, WFP</p>	<p>Inter-Agency Coordination team informed WFP that refugees who are not hosted in RACs, are asking where and how they can access food assistance</p>	<p>Activity: If any NGO, member of FSWG, can assist in this regard, are kindly asked to share their contacts with the Inter Agency Coordination Team. CRS and AAR Japan will follow up, as they have similar programmes.</p> <p>Deadline: 30.08.2022</p>
<p>Winterization plan by FSWG members</p> <p>Bahodur Umarov, WFP</p>	<ul style="list-style-type: none"> • There is an idea at inter agency level to come up with a winterization strategy in the country. This plan will serve as an advocacy tool to be used by all organizations. • WFP, as chair of FSWG was asked to provide a brief overview of which sector members will specifically do in terms of additional winter support in Moldova. For members of FSWG means if we have any extra activities planned for improve food security during the winter period in Moldova. 	<p>Activity: Members of FSWG, who are planning winter related activities, must send its inputs to WFP who will share them with inter Agency</p>

<p>Update by AAR Japan on RACs' handover</p> <p>Bahodur Umarov, WFP</p>	<ul style="list-style-type: none">• ID 35 Chişinău, Zelinski, 15 street, Sanatoriul Provizoriu de Bază "Întreprinderea de Stat" SPB CONSTRUCTORUL" (sanatorium) - They deliver IK food items weekly, as the RAC has a big kitchen and cooks. About 100 refugees are hosted there.• ID 117 Chişinău Bogdan Voievod, 8/1 street, Colegiul Tehnologic din Chişinău, căminul nr. 2, (student dormitory) - They deliver one hot meal (lunch) a day and IK food items for breakfast and dinner. The RAC has a very small kitchen. About 25 refugees are hosted there.	<p>Activity: Acted and HelpAge will conduct visits to those two RACs, to see the feasibility of taking over them from AAR Japan at the begging of October.</p> <p>Deadline: 30.08.2022</p>
