- Reporting is still low (27 out of 116 registered organizations submit reports)
- UNHCR will continue promotion of tool on national and field level
- IMs of partner agencies requested to promote the tool also among their partners
- Question: Is it possible to get access to contact information of agencies reporting?
  - Agencies are registered with contact details in Activity Info. Users do not have access to this level of the database. However, Sector Coordinators and IM of Sectors can file a request on <u>polwarrpsupport@unhcr.org</u> to request access to contact information of agencies reporting in their specific sector, for the purpose of improved coordination.

#### 3. RRP Recalibration Update

- Recalibration Exercise completed
- 29 agencies have submitted an update on their programming, on winterization and prepositioning
- The overall budget of RRP is potentially increasing from USD 740 Mio to approx. USD 780 Mio, final is not yet confirmed
- Focus of interventions shifts stronger towards Basic Needs & Economic Inclusion as well as Education and Shelter
- Funding Level is at USD 495 Mio<sup>1</sup>. and Spending at USD 227 Mio
- Information to be compiled and shared with HQ in the coming week
- Towards End of September Beginning of Planning for RRP 2023 sectors are invited to revisit the results framework and suggest additional/ modified indicators where necessary

## 4. Site Monitoring – process for cooperation

- multiple partners have expressed interest to support site monitoring exercise
- with IOM cooperation has advanced the most
- Challenges have surfaced on data protection and data sharing
  - REACH has consulted a lawyer who will elaborate a form to be signed between REACH and supporting agencies
  - The issue is that personal information on site managers cannot be easily shared
- Suggestion from UNHCR: Agencies that want to contribute to Site Monitoring should prioritize the sites, for which they have already access and contact information, so there is no need for REACH to share such data.
- If agencies have access to and contact to sites, they can therefore easily start collecting data.
  - Question: Will data of survey be available to partners?"
    - All data will be uploaded to RIDL.UNHCR.org. All Agencies who wish to access this data can address their request to <u>polwarrpsuppor@unhcr.org</u> by stating the objective and intentions for accessing the dataset.


#### 5. Service mapping – Update


**Background**: Various initiatives have been launched to date, there is lack of information sharing among those. Many organizations and FO have carried out their mapping which is either service specific or geographically targeted.

<sup>&</sup>lt;sup>1</sup> This figure differs from the reporting provided by the Refugee Funding Tracker, as it was collected separately in the context of recalibration exercise. Coordination team will aim to align the reporting in the future.

**Our role**: support the relevant sectors with solutions to collect, validate and present data. Exploring options to share such mapping with refugees at later stages together with AAP WG. For this moment we consider use AI for the stage one (for agencies that want refer to the service)

Main challenge: is keeping it upgraded regularly, have the data verified.





**Protection profiling and monitoring**: the same form is used by all countries that involved in RRP and now Belarus and Bulgaria where included. We are working on the roll out of the new form (by Oct); all who want to have a look at, and extract analyses please let us know.
