Update on recent developments that took place at PBS	 UNHCR: On Tuesday, September 13th, the Palanca Mobile Team was in Olanesti (Stefan-Voda) continuing its outreach community activities. Last week two containers for the security team were delivered and installed and now we are working for the electricity connection inside of them. On Friday, September 16th, a UNICEF Delegation from Geneva visited the Palanca BCP. Also, on Friday, September 16th, an evacuation of 94 refugees from Mykolaiv and Odessa took place. Refugees were evacuated by 3 buses organized by Be An Angel Organization. The refugees were accommodated at the tent camp to overnight and they left the day after, departing for Germany. The gravelling woks of the parking area are going well. They are expected to be finished by the end of the current week. On 20 September, 60 refugees, 20 of whom were children, transported by the GLORIA organization, to were met at PBS by humanitarian actors. On 21 september the delegation from Action Against Hunger were at PBS and we have spoken about the Food provition and management of the waste. UNHCR is waiting for a bus from Be an Angel with 33 people at 4 pm 	Activities that took place during the week
General updates from all organizations on activities at PBS.	IGSU: Following the visit of the Action Against Hunger, we agreed to supply the tent camp with a fridge to store alterable goods. Blue Dot – are continuing their service at the bus station as usual. No essential updates. UNFPA – Continues its work at PBS but also at the border. They introduced their new colleague who is a project co-ordinator. IsraAID: They could not contiune their activity on the territory of the PBS because they had lack of workers, also this problem is going to be solved and they believe that next week they will be able to resume their activity on the territory of the PBS. ACR: Informs us about the fact that the coordinator on the territory was changed and will be taken over by Nicolae who will be responsible for the staff of the ACR.	Informing all actors about their activity at PBS

GSS – There are no updates. They inform us that it is necessary to create a possibility to monitor the luggage of refugees coming to PBS to avoid situations where refugees take other luggage than their own. **ACTED** - There are no changes in activity, they remain receptive to intervene in necessary situations. They continue their activity of transporting people. They also distributed leaflets to organizations in Ukraine to inform people about free transport from Moldova. Moldova for Peace: Have not update, they continue their work as usual without any incidents that deserve more attention. IOM - They continue to provide support and to help people arriving at the bus station and at customs. They will inform us about eventual evacuations from Ukraine. **INTERSOS** – They don't have many updates, they continue to offer the same services. Coordinate with NGOs in the territory. They are involved in solving the two cases that deserve more attention. LCA(CDA): They continue to provide legal assistance to those who need it, they are present in PBS but also in customs **Helvetas:** Continue to be involved in helping and supporting those in need at PBS. They noticed that Ukrainian people are not noticed about free transport from Moldova, thus, they consider it necessary to intensify the information of citizens who leave for Moldova from Ukraine. The need to inform more actively people coming from Ukraine to Moldova about free **AOB** transport offered in Palanca. **UNHCR:** Informed the PBS actors that for the winter period heaters will be provided in the food tent.
