Presentation by David Lungu from LOGS Group	LOGS - Field work in Timisoara <ul style="list-style-type: none"> • LOGS started in 2020, when a lot of refugees from Syria, Afghanistan were living on the streets. LOGS started involving the local community ever since to assist the refugees. 	

	<ul style="list-style-type: none"> • Center opened in 4th of March • At the beginning of the crisis, LOGS covered urgent humanitarian needs like housing, food, medicine, access to basic services. • With time, they added cash assistance, psychological therapy, housing, financial support, education/cultural activities, facilitating access to jobs and schools • May - Opened Casa LOGS 2 • June - moved to the new Casa LOGS • ATM, LOGS is working with 721 beneficiaries - social work, cultural act, access to jobs/doctors, informal and formal activities, educational activities, conversational group on Romanian (volunteers mostly). • They organised 4 summer camps this summer (3 for kids from Ukraine) - 20 kids participated in each of these summer camps; 1 summer camp for kids from a local community near Timisoara. • LOGS also participated in cultural events to raise awareness on HT
