Update from Irina Mateescu	Independent midwives' association working in Bucharest offering vaccinations, pre and postnatal services for women from Ukraine and some from Romania too. >1,300 consultations for women and children so far in Bucharest and Brasov. Barriers to accessing abortions and to family doctors who accept refugees from Ukraine were discussed and lack of translators in hospitals. Irina shared a contact number for the group and suggested they contact her organisation for referrals to family doctors. She also discussed about the abortion experiential installation that IMA is currently organising in Bucharest to try to advocate for free abortion care.

Updates from the group	UNFPA and EEIRH funding GBV training in 4 GBV centres in coordination with ANES. Safe spaces also being set up for refugees to address SRH needs including GBV. WHO will fund the trainings of the rest of the 6 GBV centres SRH working group at government level led by Mihai Horga to look at contraceptive services and an SRH strategy which can be integrated into the National Programme of Measures
Updates from the group	Daniela talked about a document she has prepared mapping IEC NGOs have on SRH. Also discussed a prevention methodology against GBV / trafficking called Empowerment through Self-Defence and she is now a trainer, along with a master trainer in Bucharest and 2 trainers in Iasi and Sibiu, a Ukrainian refugee. Daniela has contact with informal Ukrainian schools in Sibiu, but they also exist in Cluj and Brasov. The SEX vs The STORK platform also has educational videos on SRH for young people, which need funding for subtitles adding.
Updates from the group	Y4Y doing programmes for YP through IPPF discussed some SRH discussions with young people. They are expanding SRH programme in schools but need support on materials translation and technical advice. They will send these to UNICEF/WHO o look over these. Coordinating Bucharest adolescent services programmes in blue dot centres but want to get adolescents involved in peer education currently some programmes are already being run in Cluj and Brasov. Adina also asked for resources for hygiene kits as funding for this has now stopped.
