ISWG coordination way forward	<ul> <li>Presentation of key points on revising and upgrading the Inter-Sector Coordination structure and approach to make the coordination more efficient and strategic and to enhance humanitarian and development coherence, need to ensure a fit-for-purpose approach</li> <li>Strengthening humanitarian and development accountability.</li> <li>Have stronger coordination linkages among all sectors and consider medium- and long-term prospects to engage the GoJ at the strategic level.</li> <li>Define the areas where the ISWG can bring evidence-based analysis and guide the sectors.</li> <li>Improve gender mainstreaming among different sectors, one of the main findings was that the capacity varies between sectors, need to look at how to enhance capacity.</li> <li>Review the rationale of having multiple sub-sectors and taskforces under the current eight sectors.</li> </ul>	



Overlap of Food Security & Basic Needs	<ul> <li>It was discussed during the Inter sector coordination meeting to look more closely into Food Security and Basic Needs sectors based on the rationale that in a protracted crisis the coordination needs and response packages are different than in an onset crisis</li> <li>Both Food Security and Basic Needs WGs focus on humanitarian assistance to the most vulnerable groups in Jordan. Food is a basic need and a key component of basic needs for the vulnerable population. Also, there is a large overlap between actors who participate both in Basic Needs and Food Security Working groups. From a refugee perspective, no distinction between the two exists</li> <li>To strengthen the coordination structure and to be efficient and fit for purpose, the idea is to merge Food Security and Basic Needs Working Groups. This will lead to the complementarity of interventions and efficiency in coordination.</li> </ul>	- Decision: Food Security & Basic Needs will proceed with merging the two working groups into one working group.
	<ul> <li>Comments and questions:</li> <li>Basic Needs sector lead confirmed the high interest of the Basic Needs WG to create a new joint WG, Food Security is a basic need, and both sectors share the same programming, target groups, etc.</li> <li>TUA expressed their support for the idea to merge the working groups.</li> <li>ICRC: supports the merging of the working groups, since food security is a basic need</li> <li>No participant raised any question or objection in forming a joint Basic Needs and Food Security WG. All actors will be included in the merged WG. There won't be less coordination and sharing of information, in fact, it will be the opposite as it</li> </ul>
