Updated figures and announcements (UNHCR)	<p>Figures:</p> <ul style="list-style-type: none"> • Stefan presented latest figures and population movement. 2.37 M border crossing, 98.7 K stay in Romania, 93 k Temporary Protection issued, 1.2 M border crossing to Ukraine. There are 12% increase in number of arrivals in the last month and 20% in the last two months. Estimate: 81% new arrivals stay in Romania for at least 10 days. Less people are returning to Ukraine. <p>2023 RRP Important Dates:</p> <ul style="list-style-type: none"> • RRP is currently under review by Directors in the Regional Bureau Europe. • Expect to receive their comments on Country Operations by 13 December. Depending on the comments, Inter-Agency Unit (IA) may communicate with the sector leads (SLs) next week. • Countries have time to review the document until 16 December. • Sign-off is 16 December. • Official regional launch of 2023 RRP will be done on 23 January 2023. Launch for Romania most probably in February. • IA will present the 2023 RRP to the UNCT next week. • There will be a meeting with PMO and DSU to present highlights of 2023 RRP next week as well. <p>ActivityInfo, the First Dashboards:</p> <ul style="list-style-type: none"> • Facundo and Sonia presented the dashboards.

	<ul style="list-style-type: none"> • Each sector will have external and internal dashboards based on the data received on ActivityInfo. • SLs are requested to encourage as many partners as possible to report on monthly basis. • The external dashboards will be shared with the Government and the link will be placed on the data portal each month. • IA will have a monthly meeting with SLs to show what is happening in the related sector. • External dashboard will be ready after receiving SLs' comments on what to include on the dashboard as the sector's strategy. • Internal dashboard will be ready after meeting with all SLs to decide on what to include in the internal dashboard next week.
Sectoral updates (targeted, action-oriented, activities / gaps)	<p>Education WG:</p> <ul style="list-style-type: none"> • Figures for children registered in the official education system is low which does not show the reality. We are supporting Romanian NGOs delivering face to face Ukrainian education. Therefore, the figure will be changed. • Why don't we have a partner in the Education WG to support face to face education in Ukrainian via Romanian NGOs or online education? • It is important to ensure that every child receive education. <p>Livelihood WG:</p> <ul style="list-style-type: none"> • Breakthrough in the last coordination meeting; members shared more information and best practices; members were encouraged to provide employment opportunities. • There is need to urgently identify day care/service provider and Romanian language classes. • Education and Livelihood WGs will have bilateral discussion on Romanian language classes.
