

2023'S POLAND PSEA NETWORK ACTION PLAN WORKING TOGETHER FOR PREVENTING AND RESPONDING TO SEXUAL EXPLOITATION AND ABUSE IN THE REFUGEE RESPONSE IN POLAND

The PSEA Network in Poland was established right on the onset of the Ukrainian refugees' emergency. This is its second Action Plan. It outlines the priorities agreed by the Network members for 2023, aimed at preventing and responding effectively to sexual exploitation and abuse to which Ukrainian refugees may be exposed. This template provides the minimum requirements to review and analyse the effectiveness, impact and progress on measures to prevent and respond to sexual exploitation abuse country-wide. It has been adapted and contextualized for the Polish operation. The objective is to promote and document harmonized activities that contribute to implementing a robust action plan and provide the basis for tracking progress and provision/mobilization of required resources in relation to PSEA in Poland.

⁵ Community-Based Complaint Networks (CBCNs) support communications with complainants and victims while allegations are being investigated, facilitate the provision of assistance and support to victims and their reintegration into their communities. The UN has engaged with local and international organizations and representatives of communities to develop formal and informal structures and channels that are safe, confidential, and easily accessible to women, men, girls and boys to report misconduct, specifically sexual exploitation and abuse, and follow up on the status of reported incidents and receive support.

The SOPs provide the basis for inter-agency referral, sharing of information on and handling of sexual exploitation and abuse allegations, as an integral component of UNCT/HCT prevention and response to sexual exploitation and abuse. The SOPs require all signatories to have an established internal sexual exploitation and abuse complaint handling procedure in place.
