BACKGROUND AND RATIONALE

In the Ukraine refugee response, government authorities are in the lead in delivering humanitarian assistance and protection, with the support of UN, NGOs, and civil society actors. An effective and comprehensive approach to safeguarding and PSEA therefore requires engagement with various government authorities, both at central and local level. This can include, for example, advocacy, capacity building, and/or joint projects with national police, border guards and reception authorities who are on the frontline of the response, as well as with social workers, child protection authorities, local municipalities, and others who are providing services directly to refugees and other persons fleeing from Ukraine.

A number of promising practices are developing across Europe, including in Italy, where UNICEF, UNHCR and the Italian Civil Protection has launched a Toolkit (Practical Guide) for risk mitigation in the reception system (in Italian, to be translated), and in Poland, where IOM and UNHCR have piloted a joint training on PSEA for the Polish police, in collaboration with Interpol. In Romania, the PSEA Network is engaging on the Government Action Plan, conducing capacity building for government staff, and working to enhance safeguards at border crossing points and accommodation centers.

At the regional level, the Regional Protection Working Group for the Ukraine response issued a set of concrete recommendations for government counterparts in the context of vetting and registration of volunteers and volunteers and volunteers and volunteer organisations, which was identified as a particular area of risk, including of SEA, across the humanitarian response.

While work is ongoing at global level to develop a Global Government PSEA Cooperation Framework (led by UNICEF), a number of policy issues remain to be resolved. This learning corner therefore seeks to highlight the ongoing practices at country level in the region, facilitate an open dialogue on the different experiences, challenges, and opportunities so far, and capture the lessons learned.
