Our journey in working on this chapter:

- The outlines of this chapter were agreed internally with AIDOS by a technical committee of experts in gender-based violence.
- Then we discussed with the Higher Council for the Rights of Persons with Disabilities and agreed upon.
- The outlines were then presented to all project partners (MOSD, HCD, Vento di Terra, AWO, Durrat Almanal D&T, and Rafeeq)





No Woman Left Behind

- After the chapter contents were developed, they were reviewed by AIDOS Technical Committee.
- Then it is reviewed by the Higher Council for the Rights of Persons with Disabilities.
- Finally, it is reviewed and approved by the Ministry of Social Development.
- At each stage, the necessary amendments were made based on everyone's feedback.
