The recommendation calls on Council of Europe member states to adopt national laws, policies and strategies which address trafficking for the purpose of labour exploitation, following a human rights-based and victim-centred approach. The recommendation's Explanatory memorandum contains a comprehensive package of measures in the areas of labour market regulation, victim identification and assistance, prosecution, corporate responsibility and liability, and co-operation.
