

Disability & Age Task Force Moldova Work Plan 2025

Scope of the Task Force

1. Promoting and mainstreaming the rights of persons with disabilities of all ages and advocating for ensuring their meaningful participation in line with principles of equality and non-discrimination, supporting the consideration of disability perspective, and removing any barriers that prevent refugees with disabilities from accessing humanitarian assistance and services provided by the government institutions on an equal basis with others.
2. Promoting equality and inclusion of older persons in humanitarian aid response, identifying older persons needs and capacities and ensuring that protection and assistance programs are inclusive of older persons and that services are accessible to them on an equal footing and non-discrimination basis.
3. Support older Moldovans and Moldovans with disabilities to enhance access to humanitarian services and assistance provided by international and local actors to improve social cohesion and facilitate the integration of refugees into the Moldovan community.

Scope of the Work Plan: The Disability & Age TF work plan is a plan to support and include all partners of the DATF. The work plan applies to activities that regard the entire Disability and Age members and not single organizations. The plan refers to activities implemented in the entire Moldova and not to a specific region of the country. The work plan is a joint effort of all the actors of the Task Force and the successful implementation of it would depend on the effort and coordination that each actor is ensuring in the different activities of the group.
