Miramar, Colón

Situation

By the end of March, the President announced a 97 per cent decrease in the number of people entering through Darien, with only 194 arrivals during the month.

In previous weeks, Mulino disclosed the phased closure of the Temporary Reception Centres (ETRM) and noted the gradual increase in north-south movements, with over 2,000 people involved.

In contrast, news reports claim that 4,000 people in these north-south movements have arrived in the community of Miramar in Colón province, at a rate of 40 to 50 per day. This situation leads to overcrowding, as many lack the funds to cover the boat costs to Colombia.

From the 299 US deportees that arrived in February, Mulino reported that only two remained in the ETRM Lajas Blancas, while church organizations have sheltered the remaining. The media mentioned that 187 of the 299 returned to their home countries voluntarily.

The Government authorized a 30-day humanitarian permit, extendable to 90 days, for 107 people from this group. The Minister of Public Security stated that these permits allow those who did not choose voluntary return to regularize their status while awaiting acceptance by another country.

Following a habeas corpus petition related to this matter, the Court ruled it inadmissible, dismissing a request to evaluate their potential removal.



Highlights

- UNHCR, UNICEF, and RET conducted a protection monitoring exercise in the Miramar community of Colón province to analyze the situation and needs of people in the reverse flow north-south. The Agency interviewed 38 people, assessing a total of 59 family members. Most interviewed (89 per cent) were Venezuelans. Thirty-four per cent of the total left their country of origin due to attacks, threats, and general insecurity.
- In Boquerón, Chiriquí, UNHCR participated in the Ministry of Women's "Pilot Project: Communities United Against Domestic Violence" workshop to develop a campaign strategy. The session outlined activities and engaged key government focal points to improve community access to protection services. Participants included officials from the National Assembly, local councils, the Judicial branch, and the Universidad Autónoma de Chiriquí (UNACHI).
- Following the transfer of US deportees to Panama City, UNHCR and NRC held information sessions on access to the asylum system in Panama for individuals staying at the Fe y Alegría shelter and for groups of individuals approaching the organizations' offices.

At the request of the Government, which ensures the security and protection of these deportees, UNHCR supports with essential humanitarian assistance and interpretation services for the National Office for the Attention of Refugees (ONPAR), the authority responsible for conducting refugee admissibility screenings for those claiming asylum.

Operational overview

UNHCR assists refugees, asylum seekers, stateless people, and other vulnerable groups to ensure they access protection mechanisms, fundamental rights, and life-saving services in Panama. The Agency supports the Government's humanitarian response at the Temporary Reception Centres (ETRM) and local communities hosting refugees and asylum seekers in Darien and Chiriquí and provides technical assistance to ONPAR.

In collaboration with the Norwegian Refugee Council, UNHCR provides information on the asylum system, offers legal support to people with international protection needs, refers those requiring specialized assistance to relevant institutions, and assists asylum-seekers with obtaining refugee status. Together with HIAS, UNHCR delivers mental health and psychosocial support services, information on protection rights, and access to essential services. Through the Panamanian Red Cross, UNHCR provides primary health care at ETRMs. The Agency works with Emberá-Wounaan host communities, supporting the development of shelter spaces and infrastructure, and facilitating integration programmes for community members, asylum-seekers, and refugees.
