ARREST AND DETENTION FLOW MONITORING (15 September 2023 – 5 July 2025)

INTRODUCTION

In response to the Ministry of Interior's (MoI) decision of 26 September 2023 to enact an "Illegal Foreigners' Repatriation Plan", UNHCR, the UN Refugee Agency and IOM, the UN Migration Agency, have collated their data on the arrest, detention, and deportation of Proof of Registration (PoR) holders, Afghan Citizen Card (ACC) holders, and undocumented Afghan nationals as well as on the outflows of Afghan nationals at the Torkham, Ghulam Khan, Chaman, Badini and Bahramcha border crossing points, to better understand the protection environment and movements of Afghan nationals returning to Afghanistan from Pakistan.


From January - February 2025, the Government of Pakistan (GoP) issued a directive, requiring Afghan nationals in Pakistan to relocate from Islamabad Capital Territory (ICT) and Rawalpindi, or else face deportation. In response, on 5 February 2025, UNHCR and IOM issued a joint press statement. Further announcements followed on the implementation of the second phase of the "IFRP", targeting ACC holders in addition to undocumented Afghans to return to Afghanistan. These decisions have resulted in an uptick in arrests, detentions and deportations of Afghan nationals, particularly in April 2025. At present, the PoR card validity is yet to be extended, following its expiration on 30 June 2025.

KEY FINDINGS AND LIMITATIONS

Prior to 2023, there was no data collected on the arrest and detention of ACC holders or undocumented Afghan nationals. Since January 2023, IOM has started to collect this data. The figures, particularly of undocumented Afghan nationals, should be considered underreported.

- During the reporting period (29 June 5 July), a total of 1,567 Afghan nationals were arrested and detained, marking a 27% decrease compared to the previous week.
- Overall, arrests and detentions decreased by 78% between the recent peak in April 2025 and June 2025.
- Out of all arrests and detentions during the reporting period (29 June - 5 July), ACC holders and undocumented Afghans represented 98% of the total rate of arrest and detentions.
- During the reporting period (29 June 5 July), 84% of the total arrests and detentions took place in Balochistan.
- Across Pakistan, the top three districts for arrest and detention between 1 January and 5 July 2025 are Chaghi (Balochistan), Attock (Punjab), and Chaman (Balochistan).


ARREST AND DETENTION BY YEARS




% OF ARRESTS BY LOCATION (1 January – 5 July 2025)




NO. OF ARRESTS BY PROVINCE (1 January – 5 July 2025)




NO. OF ARRESTS BY DISTRICTS (1 January – 5 July 2025)

ARREST AND DETENTION FLOW MONITORING (15 September 2023 – 5 July 2025)

KEY FINDINGS

• Cumulatively, from 15 September 2023 to 5 Jul 2025, 1,129,572 individuals have returned.

• During the period 29 June – 5 July 2025, UNHCR and IOM estimate 11,517 Afghans returned through the Torkham, Ghulam Khan (located in Khyber Pakhtunkhwa), Chaman, Badini and Bahramcha (located in Balochistan) border crossing points to Afghanistan.

The number of returns and deportations have decreased, (29 June – 5 July; 11,517 returns and 1,526 deportations) compared to returns and deportations in the week prior to that (22 - 28 June; 13,500 returns and 2,041 deportations). Returns decreased by 15%, and deportations decreased by 25% compared to the last week (22-28 June). The decrease in returns follows a temporary rise in movements that typically occurs in the two weeks after Eid. The drop in deportations is linked to a

slowdown in crackdown operations, particularly in Punjab and parts of Balochistan.

For the returns from 29 June – 5 July 2025, most of the returnees were undocumented (58%), followed by PoR holders (32%), and ACC holders (10%). Majority of the PoR returns are facilitated by UNHCR.

Since 1 April, 275,539 Afghan nationals returned, of which 48,696 were deported.

Since the beginning of April, fear of arrest is the most common reason to return among undocumented/ACC holders (93%) and PoR holders (63%).

During the same time period, returnees were most likely to return from Quetta (14%), Karachi Central (12%) and Killa Abdullah (12%) in Pakistan and intend to go to Kabul (22%), Kunduz (18%) and Nangarhar (17%) in Afghanistan.







