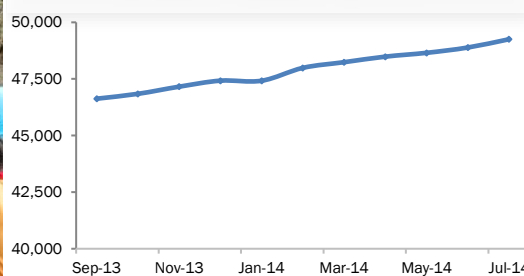

### Highlights

- Following the finalization of NFI distribution, seeds, and GFD, UNHCR humanitarian partners are now focusing on (i) expediting the shelter programme in Gendrasa and Batil, (ii) the allocation of land for agricultural use in Doro camp and mobilization of refugee community for cultivation in the areas where the land has been allocated and (iii) the de-congestion of Doro camp.
- As part of the cholera preparedness and response interventions, cholera prevention and awareness raising workshops have been conducted in Kaya and Batil camps. Similar workshops were held in Doro and Gendrasa.
- UNHCR and humanitarian partners are reviewing the WASH Plan developed to ensure uninterrupted continuity of WASH activities in the camps should international and locatable national staff be evacuated from Maban. The aim is to assess the current status of contingency stock and human resources in place to ensure the smooth progression of activities.
- Water supply in all camps remains stable. The installation of latrine and other sanitation facilities continues. No alarming WASH related concerns have been reported. Bacteriological tests are now being conducted regularly in all camps as part of the WASH water safety plan.

## Doro Monthly Updates

### Protection

- A small groups of refugee women and children returned at different times from the Blue Nile to Doro Camp. They are part of a group that left the camp during the food crisis early in the year and reported they had gone to cultivate their fields. Some reported they will return during harvest time.
- Protection screened and cleared four (4) persons for registration in Doro Camp amongst pending cases between 12-17 years among cases pending registration due to absence during biometric registration last year.
- UNHCR and DRC agreed on strategies to reinvigorate Protection Networks in Doro and Batil camps. These include setting the membership to a maximum of 40 persons (participating on a voluntary basis) who will benefit from regular capacity building initiatives. Meetings will be held on a monthly basis so that members have time to engage in daily livelihood and income generating activities.

- Distribution of 100 desks, 18,442 exercise books, 500 sanitary kits amongst schools in Doro was carried out in July.

- 69,892 water containers were cleaned.
- Of the 49, 253 individuals in Doro, 37,659 individuals received hygiene and sanitation key messages.
- Environmental clean-up campaign took place in Doro Where a total of 4,012 individuals actively participated in the exercise;
- Training of 68 sheikhs and 38 traditional birth attendants (TBAs) was done as part of cholera preparedness.
- 63 latrines were decommissioned and replaced in various villages of Doro. And 30 bathing shelters were constructed;
- 10 ORS centers identified to be set up in Doro, WASH is prepared to respond to any emergency response need

\*Family latrines are shared among 4 families, based on a average household size of 5 members, to respect the standard of 20 persons per drop-hole

\*\* Monthly soap ration have been reduced from 500 grs/p/m to 250 grs/p/m since January 2014 due to limitations in pre-positioning relief items and lack of access to Maban County.

- MSF-B has finalized preparation to set up 20 bed Cholera Treatment Units (CTUs) each in Doro and Bunj hospital for refugees and surrounding host communities. Other health facilities like health posts, will serve as a rehydration points for management of mild cases. In addition, health and WASH partners organized sensitization workshops for community leaders including sheiks, women and youth groups.
- Cholera outbreak control task force was established and meeting was held in Doro camp involving partners from health, WASH, education, camp management and community representatives.
- According to the proxy Global Acute Malnutrition rates (14.3 %) , the nutrition situation dropped continuously below the emergency threshold for the first time since February in Doro, even though above standards. Severe Acute Malnutrition is within standards. TSFP under 5 with Plumpy Sup, BSFP under 2 with CSB++ and TSFP PLW with Cereal, oil and pulses were performed by SP. SAM cases were low in MSFB clinic.
- Mother Support Group activities continued in a bid to prevent an outbreak of cholera and minimize the impact, camp level cholera preparedness and response activities have been initiated in Doro camp.
- Conclusively, the health profile of the refugee population remain stable and no suspected case of cholera was reported from the camp during the month.
