SOUTH - Refugees from Central African Republic (CAR)

While the **Chad-CAR border** remains officially closed, refugees continue to arrive in Chad. Local authorities regularly inform UNHCR of the arrival of new CAR refugees at the various border points where HCR mobile teams are dispatched to verify refugees and facilitate their relocation to a camp (on a voluntary basis).

In 2014, UNHCR has relocated a total of **9,410 CAR refugees to Dosseye** (5,619 refugees) and **Belom** (3,791 refugees) camps among whom the 36% arrived in Chad in April (3,416 individuals) and 28% in February (2,619 persons).

Assistance to Chadian evacuees/returnees

UNHCR is supporting the Government of Chad in its response to the evacuee/returnee population from CAR. In the South HCR provides support in the two returnee sites of **Danamadja** and **Maigama** the areas of **shelter**, **CCCM** (Camp Management and Camp Coordination) and **population profiling**.

On 1 July, HCR commenced its **profiling exercise** on the Chadian evacuee/returnee site of **Danamadja** (Gore). Partner, APLFT, trained and deployed 10 legal assistants who will collect necessary data to serve as a basis to formulate effective and targeted assistance, seek durable solutions and where necessary, prevent the risk of statelessness for Chadian returnee/evacuees with no links to the country. To ensure registration of the population on the site, **public criers** with megaphones inform the population of the site of the start of the profiling exercise. **Crowd control** is conducted through the distribution of tokens at the entrance to the profiling site to monitor orderly attendance of the population beginning with the most vulnerable individuals. **Verifiers (HCR staff)** monitor and maintain the electronic master list of token

distribution and ensure that persons not on the list are added. For those in need, **interpreters** are available to provide translation services. **Data Entry clerks** ensure proper collection of data for a minimum of 90 individuals (15 to 20 families) per day. **Data compilation assistants** coordinate data collection activities and conduct back up of questionnaires at the end of each day to ensure data is regularly transferred onto the database. They also ensure that at the end of each week data is cleaned up, reconciled, analyzed and submitted as a table capturing findings. The profiling exercise will commence in Maigama in the next weeks.

SHELTER

To date, a total of **1,127 shelters** have been constructed in **Danamadja** including 877 with plastic sheeting, 214 tents and 36 with brick. The current population of Danamadja stands at **11,193 individuals**. Partners (WFP, UNICEF, MSF, CARE, LWF and others) continue to provide basic services.

The site of **Maigama**, established 14 June, has a population of **1,071 individuals** (317 families). HCR has completed the constructed of **740 shelters** (690 with plastic sheeting, 48 with bricks and 2 HCR tents). **CRT** has constructed 3 hangars for use as **reception centers**. CRT has also erected 3 tents and 2 structures for **maternity** purposes. Another hanger is underway to extend the **health unit** operated by IRC. **40 latrines** and **22 washing areas** are currently operational in Maigama.

Shelter/CCCM Cluster

During the reporting time, **CCCM Cluster** shared its draft Strategy for comments. This document will be shared once finalized.



EAST– Sudanese Refugees

Kerfi

There are a total of **1,118 refugees**, including 253 children under 5, living in the villages of Kerfi. Implementation of assistance in Kerfi is ongoing including construction of shelters (through partner FLM). Upon request from refugees, HCR has revised its shelter kit to include additional plastic sheeting to accommodate refugee shelter needs.

Livelihoods/agriculture: Training of 23 groups to form **agricultural cooperatives** (12 groups of individuals among the host community and 11 refugee groups) for income-generating activities has been completed. HCR, and partner LWF, have successfully negotiated 500 hectares of agricultural land for refugee use. Preparation of **100 hectares of land, distribution of seeds** (sorghum, peanuts and millet) as well as **agricultural tools** have taken place. The government has provided 3 oxen-drawn ploughs for agriculture. A **vaccination** campaign was also organized and 9,725 heads of cattle vaccinated.

Energy/environment: The distribution of **energy-saving ovens** continues with a total of 102 ovens distributed to refugees in Kerfi.

As part of UNHCR's initiative to establish a brick factory, a quarry has been identified by UNHCR engineer. In support of this project, the Mayor of Kerfi has allotted land for

the project and relevant documents have been issued. Construction of the brick production center is planned for July (2014) and brick production will begin in August. This project will allow UNHCR to partly cover the shelter and infrastructure (including community center) needs of Kerfi until the end of the year.

Health: Based on a review conducted by a joint team of UNHCR and its partners, HCR is providing support to the local health center in Kerfi through medication and drugs, basic medical supplies and additional qualified medical staff. The additional staff have been deployed to the health center and will help to improve the management of health-related issues on the site. Referral mechanisms to Goz Beida are in place.

EDUCATION : Transition

WASH: To promote sanitation, four additional dumpsites have been completed for use.


EDUCATION: Sudanese refugee students in eastern Chad are preparing to take the level 8 exams signaling the end of primary education according to the Sudanese academic curriculum. Starting in October 2014, the next academic year, all Sudanese refugee students will follow the Chadian curriculum. Awareness raising, teacher training, selection of teachers and introduction to the new curriculum is ongoing. In Kerfi, students will be attending the local school, following the national Chadian curriculum.
