**1. UNHCR Updates**

**UNHCR new arrivals' registration updates (23 Feb-1 March)**

- 3,858 individual processed in Raba during the reporting period (same as last week: 3853 arrivals). 87% new arrival and 13% re-entry.
- 56.8% are minors.
- 96.3% entered Jordan through eastern border crossings (91.8% through Ruwaished - Hadallat and 4.5% through Al Rogoban - Sub Rogoban).
- Areas of origin: 51.5 % from Dar'a, 13% from rural Damascus, 12.4% from Homs and 9.4% from Aleppo Governorates.
- Cumulative number of individuals processed in Raba since the opening date (29 December 2013): 11% re-entry and 89% new-arrivals.

**Other updates**

- 228 government organised returns
- 372 birth certificates (cumulative figure for Zaatari)

**Verification updates (cumulative statistics)**

- 17,598 individuals processed between 27 January and 3 March 2014.
- 15,455 are active and 2,133 individuals have been totally inactivated for reasons such as multiple registration, death, returns, etc. (12.1% of verified inactivation). In addition to this, 2,183 have been so far inactivated as they did not show up after 10 days from the initial scheduled interview and their documents have been sent back to Raba (unverified inactivation). This brings the total cumulative inactivations to 24.5%.
- As of today, an additional 1,434 individuals are on hold, pending inactivation, which happens 10 days after the initial no-show date.
- 58% of the active individuals are minors.
- 3,185 (20.7%) are under 5 years old.
- As of next week, an average of 1,500 individuals will be called every day.
- New caravans in the SRCD area have been equipped with AC today. SRCD is planning to start cabling them tomorrow. When the new caravan is ready, the issuance of MOI service cards should accelerate.

## 2. CP/SGBV updates

- Child labour:  
The child protection meeting included a presentation on child labour and children living on scrap (SCI). The group identified child labour as group priority – action plan under development. Areas of work include: law enforcement; child-centred services for child engaged in labour; cash for work; community outreach/awareness; data collection; education/informal education (support services).  
UNHCR, UNICEF and ILO producing a leaflet and poster on child labour on legal issues. Discussing with SRSD, MoL.  
Amman: Inter-agency CP/SGBV key messages are being finalised.
- Child recruitment posters also being finalised and will be distributed; considering an accompanying video. Some key messages for Children in Armed Conflict, but will only be used by CACWG
- SGBV – safety audit: To be discussed in more detail by Zaatari Protection meeting
- CP/SGBV SOPs training: More coming – Chair to circulate training schedule

## 3. WFP

- Second cycle in February has been completed – 115,000 in camp. WFP undertaking assessment for welcome meals. First cycle of March for in-kind food distribution is the final cycle; increasing vouchers to 10 JOD for second cycle.
- School feeding programme ongoing. WFP, through UNICEF to Save the Children-Jordan, distributed water bottles for school children.
- WFP partaking in joint UNHCR participatory assessment in urban areas.
- Currently difficulty with bakery supplies.
- WFP, NRC, UNHCR to discuss welcome meals at meeting on 10 March.
