Note: the purpose of this meeting was to discuss the Zaatari WASH minimum standards and monitoring framework. Therefore the WASH agency updates were very brief.

Agency updates	
Mercy Corps	MC is waiting for an entry permit from SRAD before they can start work on borehole number 3. Delays have related to change in the original plans. Once the permit is received work will start within 24 hours.
ACTED	<ul style="list-style-type: none"> • ACTED are in the process of finalizing the site for water tank disinfection in district 8. This should be operational within 1-2 days. • ACTED are repairing locks on toilet doors in their districts. • ACTED will distribute diaper bins in 12-16 female WASH blocks as a pilot project. Habib to share email from Michelle which explains the pilot in more detail. • ACTED will soon start the disinfection of water tanks. There are 1,500 water tanks in ACTED districts and disinfection will take 2-3 months.
Oxfam	<ul style="list-style-type: none"> • Oxfam will meet with community leaders on Monday to discuss the planned water network. • Oxfam is facing challenges with district level water distribution monitoring. This was discussed further at a UNICEF-ACTED-OXFAM-JEN meeting last week. • Oxfam conducted a PHP training last week. • ACTED is still waiting for feedback on the maintenance factsheet, to be received by COB today. • Two new blocks masonry WASH centers in districts 8 are now completed, with 9-12 underway. All prefabricated/dalals WASH blocks will be replaced in D#8.
UNICEF	<ul style="list-style-type: none"> • Reported problems at borehole 1 yesterday due to a power cut when the submersible pump stopped working. Contractors are onsite to fix the issue. • 3,700M³ of water is delivered to the camp population everyday through ACTED.
JEN	<ul style="list-style-type: none"> • JEN have finished marking water tanks in district 3 and will start in districts 4 & 5 soon. This will take 3 more weeks. • JEN are assisting Oxfam with disinfection of public water tanks. Disinfection of water tanks needs to be incorporated into the minimum standards.

	<ul style="list-style-type: none"> JEN to send turbid water proposal to UNICEF by the end of today.
IMDAD	<ul style="list-style-type: none"> A new motor has been installed at the wadi. Reports of greywater collecting in districts 5 & 6. JEN are aware of the issue and planning to plant trees in this area to alleviate the problem.
Open hands	<ul style="list-style-type: none"> Gendarmerie informed Open hands that they require more water. De-sludging on-going with no reported concerns.
REACH	<ul style="list-style-type: none"> Only 3% of WASH centres are meeting all minimum standards. Inappropriate waste disposal arrangements remain a reason why WASH centres fail to meet standards. REACH report distributed during the meeting.

Action Points		
1	JEN	JEN to share the turbid water proposal by the end of today [action rolled forward].
2	UNHCR	Matthew (UNHCR) to act as the focal point for the Zaatari WASH minimum standards document. Matthew to update the document based on today's discussions and circulate.
