<b>Presentation on Community Support Volunteers for UASC Toolkit by UNHCR</b>	<p>UNHCR Senior Regional Protection Officer gave a presentation on the new toolkit Community Support Volunteers for Unaccompanied and separated children, Concept was developed based on experience from across the region and the recognition that:</p> <ul style="list-style-type: none"> <li>o Unaccompanied children are living independently</li> <li>o Separated children in family-based and caregiver are facing specific challenges, and in some cases varying degrees of risks.</li> </ul> <p>Community-based protection is a key approach adopted by child protection actors</p> <p>The Community Support Volunteers for UASC Concept/Toolkit is an effort to facilitate the establishment</p>		

	<p>and management of a more structured programme that builds on community knowledge and linkages to provide:</p> <ul style="list-style-type: none"> <li>o Mentoring &amp; support to UAC living independently</li> <li>o Support for families caring for separated children</li> </ul> <p>Volunteers are members of the community, and are vetted through a systematic process (using a Specific screening and reference check tools). They are identified, trained, mobilized and managed by a child protection actor (the organization that is responsible for child protection case management work)</p> <p>Volunteers perform a role that is, in a way, an extension of the Case Worker. Indeed, they are supervised by the Case Workers, who guide them, monitor their work, and support them. <b>Regional Google Drive by UNICEF and UNHCR</b>	<p>UNHCR Senior Regional Protection Officer presented a new product the “SyriaCrisisCPTools” is an interagency online repository for child protection actors across the MENA region, with a specific focus on those working in the Syria refugee response. The purpose of the repository is for sharing child protection resources and tools among those working on similar issues, and to facilitate exchange of knowledge and to maximize the use of available material.</p>		

	<p>The repository contains a wide range of child protection material, including guidelines, manuals, training tools, as well as information leaflets and reports developed for or by organizations working Within the region. It collates and organizes materials available publically on various sites, as well as material developed by organization's for specific settings. While the repository is focused on the humanitarian response to the Syria refugee situation, it also includes materials related to IDPs and Other populations affected by conflicts in the region.</p> <p>The "SyriaCrisisCPTools" has been created by UNHCR and UNICEF, with support and contribution from organization's working across the region. Materials are continually being uploaded and organized as they are sourced from across the region.</p> <p>The repository can be accessed by all child protection actors in the region. 	<p>Technical Sub-Coordination Committee (PTC) under the umbrella of the National Team of Family Protection (FPT) in Jordan aims to provide a forum for coordination and collaboration between all actors working at the policy level, and national and international organizations working on the technical level (field level) on protection issues</p> <p>The scope of the work includes the prevention and response to protection issues in Jordan, the member's ship of that committee Ministry of Education (MoE), Ministry of Labor (MoL) Ministry of Social Development (MoSD), Ministry of Health (MoH), Family Protection Department (FPD) NCFA, UNICEF, UNHCR and UNFPA.
