As for IOCC's Shelter upgrade project, it has been applied for the MoPIC approval and as soon as IOCC gets the approval, implementation will start.</p> <p>INTERMOS: there is no fund up to now for shelter projects, but in case INTERMOS receives any funds, there is a list of activities they can implement and a waiting list for identified beneficiaries.</p> <p>UNHCR: Recently a PPA has been signed with NRC in the camps. The relevant data to camp projects will be shared shortly. Technical Guidelines	<p>The technical guidelines have been shared previously with the Shelter working group. All comments received from partners were complied.</p> <p>There are no fundamental modifications on the guidelines, except for the "<i>Upgrading of Sub-standard Shelters Technical Guidelines</i>", as the WASH/Shelter task force revised it and added few comments from WASH perspective. No changes on the scope of work for shelter partners. The activity is more like a partnership between the two sectors.</p> <p>There has been a discussion over the flexibility of the guidelines and whether implementing partners have a margin in modifying their interventions slightly according to the context.</p> <p>The Technical guidelines were endorsed by the Shelter WG and will be shared and uploaded to the shelter page of the web-portal.</p>	<p>All partners</p> <p>Botros (IOCC)</p> <p>(Rawan) UNHCR</p>
