Hydrogeologist report	<ul style="list-style-type: none"> <li>- A Hydrogeological expert came to review the hydrogeological situation of Azraq and Zaatari camps.</li> <li>- Groundwater extraction from the 3 Zaatari boreholes has a very limited impact on groundwater resources when compared with the massive groundwater extraction for irrigation outside camp boundaries, therefore although Azraq is a more water-scarce area, since a water security point of view, the camp is safer as available drinking water resources are not threaten by irrigation activities.</li> <li>- Once the report is finalized, Unicef will share it with partners.
