

SITUATION ANALYSIS

During the reporting period:

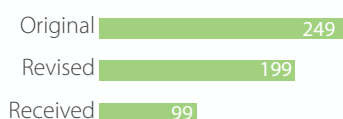
- 60 health staff from MoSA were trained on nutrition screening and referral to ensure timely detection of acute malnutrition among vulnerable children under five receiving social services at SDCs. In PHCs, coaching of healthcare providers on malnutrition screening, referral and management continued as part of the Integration of Nutrition Screening in primary health care and by the end of December, the project was handed over to MoPH.
- The 1st phase of a mission aimed at looking into means of reinforcing the Expanded Programme on Immunization (EPI) and the role of the private sector in doing so was concluded in December. The report on findings should be accessible soon on the MoPH website.
- Preparations for the polio mop-up vaccination campaign to take place in January and February 2016 targeting 136,253 children in high risk areas included the development and implementation of micro-planning tools as well as the orientation of caza physicians.
- As part of the School Health Program; 250 physicians involved in the medical screening process of students were introduced to the revised version of the guidebook on school health screening.
- A national HAZMAT (Hazardous Material) emergency response team was created at MoPH to ensure public and medical safety throughout the mitigation of hazardous materials incidents all over Lebanon. As such, 13 CBRN (Chemical, biological, radiological and nuclear) training sessions were conducted for 242 participants "first responders" from the Civil Defense, the Medical Team and the Lebanese Red Cross.

Similar to previous months:

- Access to life-saving and obstetric hospital care continued to be supported through a network of 56 supported hospitals with 9,523 Syrian refugees received urgent hospital care of which 54% were for delivery care.
- Trainings of healthcare providers on Effective Vaccine Management, Reproductive Health Service Delivery Guidelines (SDGs) and Clinical Management of Rape continued in order to improve health service delivery.
- At community level, awareness sessions on Infant and Young Child Feeding (IYCF), family planning and safe motherhood continued in the Bekaa and North areas reaching 4,445 women. A total of 3,660 dignitary kits were distributed following the different sessions.

PEOPLE (In Need/Target)



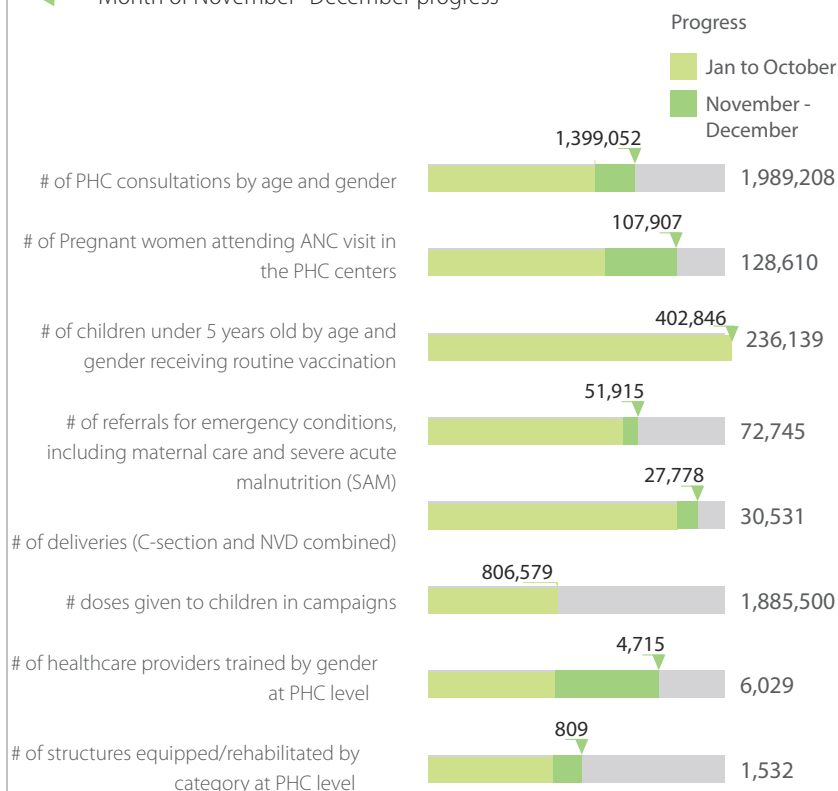
