Welcome, Introduction & endorsement of previous meeting minutes	<p>The HP meeting was chaired by Solidarites International and hosted by International Medical Corps (IMC). After welcoming remarks, all agencies present had the opportunity to introduce themselves. Update on the current HP work being done by agencies (who has done what where)	<p>IRC:</p> <p><u>Eleonas</u>: there are still some problems with site management related to the division of the camp that excludes one part from the activities that are organised in the two others. IRC assists the Site Manager 2hours/day. Successful cleaning campaigns are lead with the population every 2 days and some potential representatives for WASH committees have been identified. The Site Managers have not yet been informed about the WASH committees.</p> <p>The Hygiene kiosk is on order process and the design of a shaded area close to it is ongoing.</p> <p>A base line survey based on ECHO indicators started today and monitoring tools have been implemented as well.</p> <p>Concerning the waste management improvement, Focus Groups Discussions will be soon organized.</p>	<ul style="list-style-type: none"> • Share the IRC NFI proposed kits on the dropbox • IMC list to be shared 	<ul style="list-style-type: none"> • IMC

	<p><u>Schisto</u>: successful cleaning campaigns and handwashing activities have been organised. IRC will extend the laundry area and the residents also have access to washing machines. Signs were put on bins and wash facilities to improve the use and raise awareness.</p> <p>The army is currently distributing Hygiene items from donations, IRC will distribute the UNHCR kits as soon as they receive them.</p> <p>DRC: is not leading Hygiene Promotion activities yet.</p> <p>IMC : In <u>Skaramangas</u> IFRC leads distribution and organize them through QR codes tickets given per family and communicating an appointment for each House Hold. IMC faced problems of vandalism so that distributions for children have been put on hold. They particularly met difficulties during Ramadan. IMC is planning to organize HP awareness activities with children through the school including NFIs distribution. IMC wishes to do distribution of UNHCR kits depending on the Commander validation. Distributions are planned every 3 weeks for NFIs. IMC will distribute cleaning items per House Hold at the end of August.</p> <p>In this camp there are some problems of cleaning with the private company that is not taking the food thrown on the floor. For this reason IMC decided to involve refugees to collect it themselves starting from this week. The cleaning will be lead by IMC with the Red Cross every day for 2 hours except weekends.</p> <p>Concerning the garbage collection there are some difficulties with the schedule of the navy and municipality. In fact last week they spent 4 days with no garbage collection. DRC is in charge of pushing the 2 actors to coordinate and increase the</p>

	<p>garbage collection to the camp. IMC will change 8 big bins (660L – 440euros/bin) that will be emptied by a private company as they are not part of the municipality bins.</p> <p>Solidarites International (SI): Regarding HP activities SI has lead 2 days activities in Elliniko 1 through Save the Children and is still providing the site management with cleaning items and hygiene items. SI activities are coming to an end at the end of July in Elliniko. Due to a lack of time and resources, the HP week that was discussed with DRC could not be organized.</p> <p>Solidarites International and Apostoli/NCA/IOCC for Malakasa camp: Due to an incident in Malakasa warehouse that has been broken into by the residents, NFI and hygiene items have been put on hold. SI and Apostoli hygiene items/NFI stock's were stolen. As a consequence, the MOMP has enforced its presence and is working on the improvement of the site management and the NGOs coordination. Several decisions are ongoing and will probably have an impact on the activities planned.</p> <p>In addition, IOM was supposed to do a hygiene kits distribution mid-July but due to customs problems the distribution is on hold. SI will take over the procurement of the hygiene items and will lead the distribution in collaboration with NCA/Apostoli/IOCC and Boat refugee Foundation.</p> <p>HP activities with children and women are ongoing weekly as well as cleaning campaign in collaboration with Boat refugee Foundation.</p>

	<p>Apostoli/NCA/IOCC:</p> <p>A distribution of UNHCR kits is planned in Aghios Andreas.</p> <p>In Aghios Andrea HP activities with women and cleaning committees are already in place with close collaboration with NGOs.</p> <p>Signs for wash facilities were put in Inofita and discussions with the education partner are ongoing to start HP activities.</p>		
WASH committees/community mobilizers	<p>IRC is working on the implementation of WASH committees. SI /Apostoli are facing difficulties with the new Site Management and will probably need to readjust.</p>
