DISCUSSION

1. Situational updates including the NE border and Azraq Camp

- In terms of the border, WFP was able to go ahead with a one off food distribution across to other side of the berm
- WFP in partnership with IOM and UNICEF, through key informants, is planning to conduct cross distribution monitoring
- 75,000 people reached with food assistance (rice, lentils and dates), as well as hygiene item were distributed by UNICEF and IOM distributed bread
- Discussion is continuing to find a long-term solution, with no clear way forward at present
- For Azraq camp, village 5 has not changed, village 2 remains closed
- Bread is being distributed in both villages
- Supermarket has a temporary setup in village 2
- A fully operational supermarket will begin construction in early September 2016
- Two suicide attempts took place in village 5 one attempt was unfortunately successful

2. Agency Update

IRJ:

- Finalized food distribution during Ramadan in which 3,000 food parcels were distributed to beneficiaries targeted in northern of Amman
- Currently distributing food parcels in Mafraq, 3,190 food parcels distributed to 6,380 families (Syrian and Jordanian). The time frame for this project is seven months



- IRJ has received a call for proposal from CIDA to conduct food intervention in Azraq camp. The proposal is on going

CARITAS:

- Has two food security projects on going
- 1,700 Syrian and Jordanian beneficiaries received food voucher for food items which cost 60 JD as well as voucher for non-food items at a cost of 20 JD
- Another project is fresh food vouchers and vouchers for infants, targeting both Syrians and Jordanians
- Conducted awareness sessions for 1,700 families in health, nutrition and self-hygiene

RFSAN and FAO:

- Conducted two training activities on food security, GIS and data visualization in both Arabic and English. The training was on July 2016- Amman
- Disaster Risk Management Assessment report will be finished soon

IOCC:

- Distributed food vouchers to 1,200 families in Mafrag and Amman

3. JRP/3RP 2017-2019 update

- MOPIC has start the planning phase for JRP 2017-2019
- Livelihoods and food security will split into two sectors. Livelihoods will be under MoL and food security will be under MoA
- The process will be similar to last year, Comprehensive Vulnerability Assessment is under process, and will be compiled using available data (activity info, reports, assessment, etc.)
- Need to focus on food security output, budget, indicators and activities
- Information/update and invitation will be shared with you

- Noha will follow up with FSSWG partners for JRP 2016 monitoring as well as for JRP 2017-2019

4. Jordan Humanitarian Fund (JHF)-OCHA/ Food Security Sector priorities

- OCHA has informed us that the Jordan Humanitarian Financing Unit is in the process of preparing for a new call for proposal Jordan Humanitarian Fund (JHF) which is expected to be launched by mid-September 2016.
- OCHA plans to launch the call for proposals by mid-September on the basis of the priorities identified by sectors.

Inter-Sector Priorities-Food Security as of March 2016;

- 1. Continuation of food assistance targeting vulnerable Syrian refugees, both registered and unregistered.
- 2. Within government frameworks, projects that support increased self-sufficiency/self-reliance for refugees including in activities relating to agriculture.

For Jordan Humanitarian Fund (JHF) PRIORITIES



BASIC NEEDS / FOOD SECURITY:

Support to maintaining refugee households' assets through unconditional cash or household item assistance, thereby reducing the risk of exposure to negative coping mechanisms within urban areas. Azraq camp is a cross-sectoral priority. With limited economic activity in the camp, activities across sectors, designed to stimulate the economy should be prioritized.

- · Should specify how the VAF is being applied for analysis/targeting; entry into RAIS to prevent duplication of assistance
- · Multi-Sector and coordinated with PROTECTION, SHELTER with FOOD SECURITY / BASIC NEEDS

Action required:

- Partners agreed for inter-sector priorities will be the same without change at the moment as well as sector priorities for JHF
- Noha: To share FSSWG priorities for JHF with coordination unit to be submitted to UN OCHA
- UN OCHA contact will be circulated for any further information requested, done, circulated with the invitation for JHF

5. Assessments – upcoming assessments

- WFP: CFSME will be finalized in Sep.16
- IRJ: Has a data base of assessment for 7,000 families, report will be shared when its ready
