Announcements	<p>WASH WG members:</p> <ul style="list-style-type: none"> Roelof Wentzel is leaving WVI and leaving the co-chairing position for the WASH WG. It's a big loss for the group due to his distinguished efforts provided to the group. The main WASH sector partners are ACTED, Oxfam, ACF and JEN. We'll see if any of them will volunteer to dedicate a WASH person to fill this position. <p>JHF Priorities: The group Feedback for the JHF -WASH sector priorities should be shared by 26 Feb.</p> <p>JORISS training: JORISS training sessions will be conducted on 15-16 Feb, all partners were encouraged to participate to recognise the new system features.</p> <p>City of Amsterdam: The WASH Coordinators will be meeting them. They will discuss the solid waste. UNHCR.</p> <p>Berm: UNICEF is the main player at berm, ACF is lending hands very limited in certain areas and UNHCR is controlling the coordination there. UNICEF managed with the support of government to drill two wells, in two places; Adalat and Al Rukban. The first will be operated in 15 days and the other will be operated in June. The treatment unit will be installed, with capacity between 50-80 cm. Snapshots is being developed about the berm and will be shared with the group about the situation there. Snapshots will be developed for the WASH interventions; camps, host communities, etc.</p> <p>3RP – JRP planning process lessons learnt: The document is been shared with the group for their feedback. A table for 3RP and JRP activities and timetable will be developed and shared with the group.</p> <p>ActivityInfo Reporting: Tomorrow 15 March is the deadline for activityInfo reporting for Jan 2017. Indicators metrics was shared with the IM focal points including each indicator calculation. Additional training sessions on ActivityInfo will be conducted for partners who still facing problem in reporting. Sessions will take place at UNHCR office on 15 and 19 Feb, invitation was shared earlier.</p> <p>Urban Coordination The ISWG has created the urban coordination in different area in Jordan; Irbid, Mafraq and Amman. The purpose of the meetings is to increase the effectiveness of operational coordination, and thus is opened for the programme managers, case managers and other actors at the implementation level. Updates from WASH partners	<p>IOCC:</p> <ul style="list-style-type: none"> Conducted 50 hygiene promotion sessions 50, and distributed personal hygiene kits for beneficiaries attended the sessions. Reached 2000 beneficiaries in Amman, Mafraq and Zarqa. IOCC continued in partnership with JHAS distributing de-lice solutions in camps and host communities. On Activity Info, there is an indicator for anti-head lice (REF 5.2) to report against. <p>JHAS:</p> <ul style="list-style-type: none"> No updates. <p>UNICEF:</p> <ul style="list-style-type: none"> Working closely with ACTED, Oxfam, JEN and UNHCR on sustaining the services in the camps and on the network in Zaatari and Azraq. Hopefully by mid-2017, we will start seeing less tankers and water flowing. Waste water: working on increasing the efficiency of the Zaatari and Azraq wastewater treatment plans. <p>WVI:</p> <ul style="list-style-type: none"> Working on solid waste project to prepare it and take it out from ACTED in Azraq in May. <p>UNHCR</p> <ul style="list-style-type: none"> No updates. <p>JEN:</p> <ul style="list-style-type: none"> Coordinating Phase II waste water network in Zaatari. <p>ACF:</p> <ul style="list-style-type: none"> Berm: working on monitoring the water qualities and quantities. Azraq: working on hygiene promotion and maintenance and wash blocks. HC: having in Irbid 3-year-project, funded by France Development Cooperation FDC. Rewashed: working with partners in institutions in hospital and schools basically on water treatments plants and water connections. <p>INTERSOS:</p> <ul style="list-style-type: none"> Working in HC only on ITS. Currently finished Makani Plus. INTERSOS also working on other WASH interventions; winterization, protection and Cash for rent. (ITS: Informal Tented Settlements). <p>MC:</p> <ul style="list-style-type: none"> Finalising 3 projects on; pump station, storage tanks in Irbid and strengthening capacity of technology network in Mafraq. <p>Gate Foundation:</p> <ul style="list-style-type: none"> Visited Jordan for the last weeks. UNICEF facilitated their visit. It's a cooperation with Chinese university and German scientists. A summary about the IOCC agency scope of work and activities in Jordan; Hygiene Vouchers, Anti-Head Lice Treatment, Winterization, Shelter Rehabilitation, Cash for Rent...etc. It was suggested to do a map for IOCC interventions. The presentation will be shared with the WG.</p> <p>The present partners requested the below info:</p> <ul style="list-style-type: none"> IOCC procedure for the e-Vouchers (cards) issuing with banks: For its previous food and hygiene vouchers, IOCC utilized a paper voucher systems. However, for its winterization e-vouchers, IOCC signed on to be a member of WFP's OneCard Platform. Using this platform, IOCC is able to sign an agreement with WFP and utilize its relationship with the bank rather than signing a separate agreement with a bank. Utilizing the OneCard Platform, IOCC is able to access the rates and service fees that WFP gets rather than negotiating these separately with a bank.
