CCF modality will be used initially for 50-70 cases.</li> <li>• <b>CARE:</b> winterization PDM was finalized in Feb 2017</li> <li>• <b>WVI:</b> To conclude implementation of winterization activities by end of April.</li> <li>• <b>ACF:</b> finished their unconditional cash project in Feb.
