

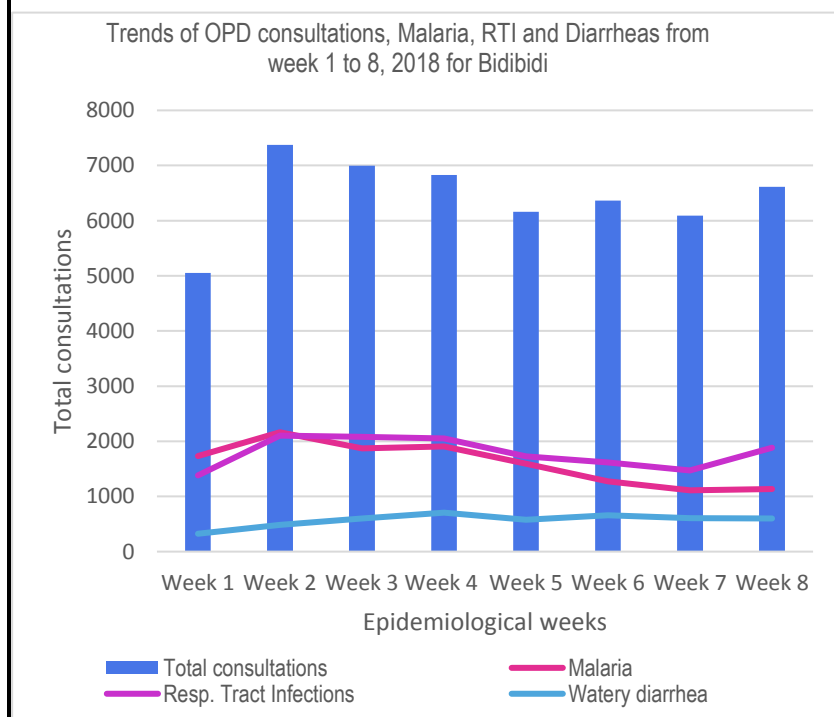

▪ OPD Consultations

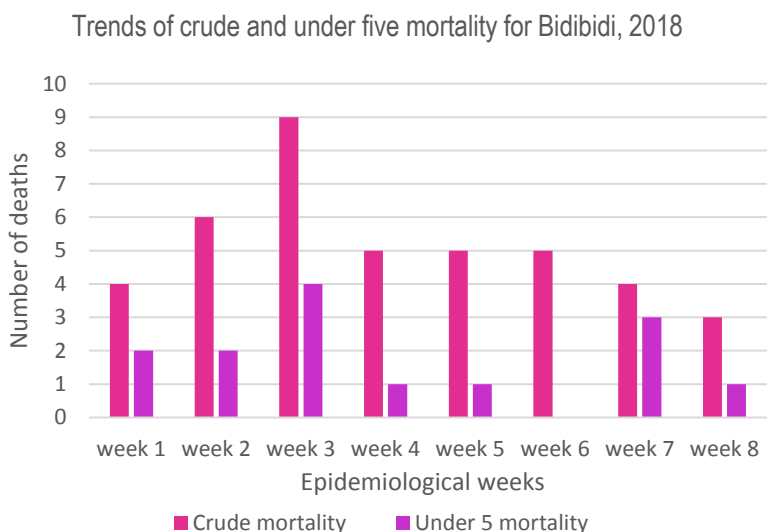
During the reporting period, a total of 6,612 OPD consultations were made compared to 6,094 reported the previous week.

The leading causes of illness (proportional morbidity) were Acute Respiratory Tract Infections/RTI (22.8%), malaria (13.8%) followed by Watery Diarrhoea/WD (7.3%); this implies that the three top disease conditions contributed about 44% of the total morbidity for reporting week.

The incidences for malaria, RTIs and watery diarrhoea this week are estimated at 4, 7 and 2 cases/1,000 persons/week respectively.

No cases of bloody diarrhoea or Typhoid were reported. No new cases/suspects for Viral Haemorrhagic Fever; Results for the last suspected case were negative for VHF's. The patient improved and was discharged.

▪ **Mortality:**



A total of three (3) deaths (1 F; 2 M), including one (1) child under the age of five were registered (1- Public Referral Health Facility; 1 Settlement Facility and 1 Community). Probable causes of deaths were as follows: Malaria (1), Cryptococcal Meningitis in ISS (1) and 1 unknown from the Community.

The Crude Mortality Rate (CMR) and Under 5 mortality rates are estimated at 0.01 and 0.03 deaths/10,000/day respectively, which are both below the emergency threshold of 1 and 2 deaths/10,000/day respectively.

▪ **Mental Health and Psychosocial Support:**

Total number of consultations during the week were 181 (75 new cases and 94 revisits). Consultations were made for Epilepsy (118), Depression (28), Psychosis (16), Drug abuse (10) and Suicide attempt (1). The Client of suicide attempt was linked to psychosocial support.

▪ **Reproductive Health, HIV/AIDS:**

Total for ANC 1 was 132, ANC 4 was 101 and PNC was 196, while 107 deliveries were conducted (with 23 deliveries by nationals). One hundred and forty seven (147) mothers were tested during ANC; one tested positive. The Number of new clients enrolled on ART during this week is 2.

▪ **Expanded program for immunization, Vitamin A supplementation and deworming:**

A total of 229 doses of DPT 3 and 213 doses of PCV3; 145 doses of measles and 105 doses of BCG were administered to children in the settlement; 502 doses of vitamin A supplements and 441 doses of deworming tablets were also given.

▪ **General updates**

- HIV and TB Performance review meetings held, with support from Infectious Diseases Institute (IDI) and Yumbe DLG.

▪ **Challenges/constraints:**

- Limited stock of Vaccines, especially BCG, Measles

Achievements: Narrative

- A total of **93** children aged 6-59 months were enrolled in the feeding programs in the reporting period (**4** in ITC, **11** in OTC and **78** in SFP). A total of **2,463** children were screened during the week.
- A total of **1237** pregnant and lactating women were screened, **12** were identified and enrolment into the SFP program.
- A total of 1,469 children aged 6-59 months were reached by MCHN while 1244 Pregnant and Lactating women were reached.
- Five (5) children under ITC and 12 under OTC recovered; No defaulters or deaths were reported this week.

Infant and Young Child Feeding:

- During this reporting period, a total of **52** mother-baby pairs accessed the 3 mother-baby areas of Yangani (**22**), Ombechi (**15**) and Kiranga (**15**).
- Out of the **52** mother-baby pairs mentioned above, **13** pairs were accessing MBAs for their first time this year while **39** came for follow up visits.
- All Mother- Baby pairs were assessed, those with breastfeeding difficulties received full assessment, and then one-on-one skilled counselling was offered. Mothers and caretakers without breastfeeding difficulties were given key messages concerning appropriate Infant and Young Child Feeding in Emergencies, and some came to breastfeed.
- Conducted 3 complementary food and cooking demonstrations at the MBAs; a total of 81 PLW participated.
